The DCY 02911 Title IV-E Single Cost Report for fiscal year 2025 covers the reporting period of July 1, 2024, to June 30, 2025. The JFS 02911 Title IV-E Single Cost Report, along with the documents required by OAC rule 5180.2-47-26.2, must be completed and filed by December 31, 2025.

For good cause and upon written application ODJFS may grant an extension of the December 31, 2025, filing deadline in accordance with O.A.C. §101-2-47-26.1. Approved filing deadline extensions are reflected below.

This reporting period establishes Title IV-E reimbursement ceiling per diem for the effective period April 1, 2026, through March 31, 2027, subject to rate card implementation. Based on Consumer Price Index data for the reporting period, an inflation factor of 4.7% has been added to the reported costs associated with this reporting period.

If an agency's cost report has been filed but ceiling per diems are not yet established, the Cost Report Status column will read "Received/Desk Review in Process." If an agency has not submitted a cost report, the Cost Report Status column will read "Nothing Filed Yet."

For maintenance ceiling per diems listed with an asterisk *, OAC rule 5180.2-47-10 establishes a contemporaneous payment system for purchased foster care services. Under this system, your Title IV-E maintenance reimbursement ceiling per diem (e.g., the amount paid to the foster parent) is set at the statewide maximum ceiling as currently established through procedure letter in Department of Children and Youth Procedure Letter No. 27 sets statewide maximum of \$500/day effective 10/1/2025.
