Director Says, There is "More Work to Do" to Reduce Infant Mortality

Director Wente participated in a panel discussion in March about what local groups and the state of Ohio are doing to reduce infant mortality. She told the crowd at the State House Atrium, “Our preliminary data for 2024 shows our lowest infant mortality rate statewide in 20 years. But we still have more work to do—by making sure every mother and baby in Ohio has access to the right care, at the right time, in a way that truly makes a difference.”

The panel was moderated by CelebrateOne Executive Director Danielle Tong and included Angela Newman-White from First Year Cleveland.

Director Delivers Remarks at First-Ever Black Maternal Health Caucus Summit

Director Wente was invited by the Black Maternal Health Caucus to speak as its Inaugural Summit on April 15. She told attendees that in order to listen to communities, families, and young people, DCY has held 15 family listening sessions with more than 350 youth, parents, and caregivers in attendance. She also noted that DCY partnered with the BUILD Initiative and the Infant Mortality Task Force to hold 14 community conversations about improving Black maternal and infant health outcomes, connecting with 82 families.
