PROGRAM UPDATES

Individualized Family Service Plan (IFSP) Grid Reminders

In response to several questions about completing the IFSP grid page, we are providing the following reminders:

- The agency that employs the individual service provider should be listed as the provider agency on the grid.
- “Department-contracted provider” (DCP) is one of the funding sources available to pay for EI services. The other funding sources include the following:
 - County Board
 - Private Insurance
 - Public Insurance
 - Parent Participation

Department-contracted providers include the following providers:

- Hearing, vision, and nutrition providers
- Councils of government (COGs) and their sub-contractors
- Other department-contracted providers

Finally, if public or private insurance is used to pay for an EI service, list the funding source on the IFSP as insurance (indicating whether it is private or public)/DCP. The primary payor of public or private insurance should be entered into the EI Data System (EIDS).
