SUBJECT: 2026 Child Care Cred Program

Background

Amended Substitute House Bill 96 of the Ohio's 136th General Assembly created the Child Care Cred Program within the Department of Children and Youth (DCY) authoring \$10 million in State Fiscal Year (SFY) 2026. This program helps make child care more affordable by splitting the costs between participating employees, their employers, and when funding allows, the state. The program has the following goals: enabling employers to attract and retain talent; assisting employees with child care costs; and sustaining the businesses of child care programs.

What is the Child Care Cred Program and who is eligible?

The **Child Care Cred Program** helps working families afford child care by sharing the costs. Families qualify if their household income is between 200% and 400% of the federal poverty level, based on how many people live in the home.

Under the Child Care Cred Program, the cost of monthly child care is shared among employees, their employers, and DCY. Employees pay 40 percent, employers contribute another 40 percent, and the department covers the remaining 20 percent, as funding allows through June 30, 2026.

To take part in the Child Care Cred Program, several eligibility requirements must be met:

• Employees must live in Ohio and have a household income between 200% and no higher than 400% of the federal poverty level, based on family size. In addition, the employee must be chosen by their employer to participate. Below outlines family incomes:

- Employers must also be based in Ohio and must select one or more employees for the program.
- Early Care and Education programs must be a child care center, preschool, or school age child program, licensed under chapter 5104 or certified by a county department of job and family services under section 5104.12 of the Ohio Revised Code.
- Families who receive Child Care Choice Voucher Program (CCVP), Early Childhood Education Grant (ECE) or Publicly Funded Child Care (PFCC) subsidized early care and education services are not eligible for the Child Care Cred Program.

To participate in the Child Care Cred Program, the employee, employer, and child care program must submit a joint application to DCY. DCY will review each application to determine if the applicants meet the eligibility requirements. Once approved, eligibility remains valid as long as all involved, the employee, employer, and child care program, continue to meet the program's conditions. An application between the employer, employee, and child care program is required to apply for the Child Care Cred Program and must be emailed to childcarecred@childrenandyouth.ohio.gov.

What happens after the employee and employer are approved for the Child Care Cred Program?

• **Child Care Selection and Enrollment**: The employee, supported by DCY, will choose a licensed child care program and enroll their child. If the employee already uses a licensed program, they may continue with that arrangement.

• **Employer Contributions:** In addition to the employer's required share of child care costs, the employer may choose to contribute to the employee's portion, either partially or fully.

What are the child care program qualifications?

The child care program shall either hold a license issued under chapter 5104 of the Ohio Revised Code or be certified by a county department of job and family services under section 5104.12 of the Ohio Revised Code, be in "open status" as verified in the Ohio Licensing and Quality System (OCLQS), and have an active DCY Provider Agreement for Early Care and Education Services.

How will the employee, employer, and department pay the child care program for the monthly child care services?

The employee (40%) and employer (40%) will pay the child care program directly for the monthly child care costs as required by the child care program. The employer may agree to contribute some or all of an employee's share of child care costs. The child care program will invoice the department (20%) each month for the child care services after receiving payment from both the participating employee and employer. A program must be in an "open status" and have an active DCY Provider Agreement for Early Care and Education Services in the department's Ohio Child Licensing and Quality System (OCLQS) to receive payment.

What is the application and funding timeline for the Child Care Cred Program?

The funding period for the Child Care Cred Program is July 1, 2025 through June 30, 2026. Program guidance will be posted on the department's website and application submissions will be accepted beginning September 1, 2025 through May 1, 2026.

What happens if an employee, employer, or child care program misrepresents their payment commitment?

If the department finds that an employee, employer, or child care program has committed fraud, misrepresentation, or deception in applying to participate, or in participating, in the program, the employee, employer, or child care program is permanently ineligible to participate, or continue to participate, in the program. The department reserves the right to pursue repayment of funds disbursed.

Child Care Cred Questions and Answers September 2025

1. What is the Child Care Cred Program (CCCP) and who is eligible?

The **Child Care Cred Program** helps working families afford child care by sharing the costs among employees, employers, and when funding permits, the state. Families qualify if their household income is between 200% and 400% of the federal poverty level, based on how many people live in the home.

2. What is the Child Care Cred Program (CCCP) cost sharing commitment?

Under the **Child Care Cred Program**, the monthly cost of child care is shared among employees, their employers, and the Ohio Department of Children and Youth. Employees pay 40 percent, employers contribute another 40 percent, and the Ohio Department of Children and Youth covers the remaining 20 percent, as funding permits.

3. What are the eligibility requirements of the Child Care Cred Program (CCCP)?

- Employees must live in Ohio and have a household income between 200% and 400% of the federal poverty level, based on family size. In addition, the employee must be chosen by their employer to participate.
- Employers must be based in Ohio and must select one or more employees for the program.

Early Care and Education programs must be a child care center, preschool, or school
age child program, licensed under chapter 5104 of the Ohio Revised Code or certified
by a county department of job and family services under chapter 5104.12 of the Ohio
Revised Code. Providers do not need to be enrolled in the "Step Up to Quality"
program to qualify for the Child Care Cred Program.

4. How do an employer and employee apply for the Child Care Cred Program (CCCP)?

To participate in the Child Care Cred Program, the employer must submit an application to the Department of Children and Youth that includes the employer, employee, employee's child(ren), and child care program information. The department will review each application to determine if the applicants meet the eligibility requirements. Once approved, eligibility remains valid as long as all involved, the employee, employer, and child care provider, continue to meet the program's conditions.

5. When is the deadline for submission?

All applications are to be submitted to <u>childcarecred@childrenandyouth.ohio.gov</u> by May 1, 2026, to be considered for funding. Funding cycle ends June 30, 2026.

6. What happens after the employee and employer are approved for the Child Care Cred Program?

- **Child Care Selection and Enrollment**: The employee, supported by DCY, will choose a licensed child care program and enroll their child. If the employee already uses a licensed program, they may continue with that arrangement.
- **Employer Contributions**: In addition to the employer's required share of child care costs, the employer may choose to contribute to the employee's portion, either partially or fully.

7. What are the requirements for the employee's child care program?

The child care program shall either hold a license issued under chapter 5104 of the Ohio Revised Code or be certified by a county department of job and family services under section 5104.12 of the Ohio Revised Code, be in "open status" as verified in the Ohio Licensing and Quality System (OCLQS), and have an active DCY Provider Agreement for

Early Care and Education Services. The department shall not require participation in the Step Up To Quality Program to be an eligible program.

8. For the participating child care program, what are the terms and conditions of the Provider Agreement for Early Care and Education Services?

9. What happens if an employee, employer, or child care program misrepresents their cost sharing payment commitment?

If the department finds that an employee, employer, or child care program has committed fraud, misrepresentation, or deception in applying to participate, or in participating, in the program, the employee, employer, or child care program is permanently ineligible to participate, or continue to participate, in the program. The department reserves the right to pursue repayment of funds disbursed.

10. Are families who receive other state child care subsidies eligible to apply?

Families who receive Child Care Choice Voucher Program (CCVP), Early Childhood Education Grant (ECE) or Publicly Funded Child Care (PFCC) subsidized early care and education services are not eligible for the Child Care Cred Program.

CHILD CARE CRED PROGRAM: APPLICATION

This Child Care Cred Program Application outlines the terms of participation between the employer, employee, and child care program in the Child Care Cred Program, established by House Bill 96, passed by Ohio's 136th General Assembly and administered by the Department of Children and Youth (DCY). The program is designed to make child care more affordable for working families by sharing costs among employees, employers, and—when funding allows—the state. The program advances three key goals:

- Supporting employers in attracting and retaining a skilled workforce
- Assisting employees with the financial burden of child care
- Sustaining the operations of child care programs across Ohio

Eligible families must have household incomes between 200% and 400% of the federal poverty level, adjusted for household size. Eligibility is subject to verification and continued compliance with program guidelines. Under the cost-sharing model, employees contribute 40% of monthly child care expenses, employers contribute another 40%, and DCY covers the remaining 20%, as funding allows through June 30, 2026. Below outlines income guidelines by family size:
