- Approximately 432 cases have been filed alleging or implicating COVID. Records indicate that 385 cases were closed with 47 cases still pending.

#### **Vaccine Mandate Inventory.**

- Approximately 212 cases regarding vaccine mandates have been filed. Records indicate that 192 cases were closed with 20 cases still pending.

#### **AG Litigation Inventory.**

- Nothing new to report.

### **GENERAL**

OCRC ACADEMY. The first OCRC Academy was held on November 30th and December 1<sup>st</sup> at the ODOT auditorium. We offered 10 continuing legal education credit and 10 credits for SHRM.

We had approximately 100 in attendance, in-person and virtually combined. We hosted two representatives from the Indiana Civil Rights Commission. We had volunteers from the regions from around the state who helped to make the Academy a success.

This was a huge undertaking, but Bradley Dunn and Mary Turocy along with other Commission staff pulled it off. The staff assisted with the online attendees, helped with registration, and gave presentations. Other staff were there to assist in whatever capacity necessary. The evaluations were extremely positive.

The OCRC Academy was well received, 762 and attendees wanted to know when we were going to have another one. In addition, we have received requests for training on topics covered during the Academy.

DR. MARTIN LUTHER KING, JR. ART, ESSAY, and MULTI-MEDIA CONTEST. This event is scheduled for February 23, 2023, and it will be at the ODOT auditorium. Planning for this event has been underway for several months. A committee of Commission staff will be reviewing the submissions for awards on January 10, 2023.

FACILITIES MANAGEMENT. Akron is embarking on the move from the 2<sup>nd</sup> floor to the 4<sup>th</sup> floor. Akron's move is from December 19-21 of 2022. Akron staff will telework until approximately January 2, 2023, when they should be able to return to their new offices. These dates are tentative and subject to change, but at least we have dates to work towards.

### TECHNOLOGY

CASE MANAGEMENT SYSTEM. The process is moving forward. The CMS Project Manager and Developer have been meeting with key members of the Commission's staff as they proceed to develop a system to accommodate the needs of the agency.

INTERVIEWS. The Human Resources Department and its selection committees have been interviewing several candidates to fill the following vacancies: Investigator positions 1 and 2 (Columbus), Program Administrator 1 (Columbus), and Investigator position (Toledo).

The Program Administrator 1 position (Compliance and Enforcement) has been filled by Leslie Morrison, who commenced her new position on December 5, 2022.

Conditional offers have been extended to the successful candidates for the Supervisor position (Dayton), and the Investigator position (Cleveland).


