## GENERAL

HOUSE BUDGET TESTIMONY. On February 14<sup>th</sup>, the Ohio Civil Rights Commission provided budget testimony to the House Higher Education Subcommittee. The Committee showed a keen interest in several aspects of the Commission, such as our case numbers, staff numbers, mediation program, training for prevention of discrimination as well as our mental health booklet.

OHIO ADMINISTRATIVE CODE. We have amended our rules to absorb the changes made by HB352 as well as to amend the rules for clarity and corrections. The rules were submitted to the Joint Committee for Agency Rule Review (JCARR). We held our public meeting on the rules on Monday February 27<sup>th</sup>. So now we are awaiting the public hearing before the general assembly JCARR committee. If there are no issues, we will file a final version, which will then become effective.

ALL HANDS MEETING. Our All Hands Meeting is currently in the planning stage. We are considering having the All Hands meeting in person this year. We are trying to schedule it sometime in September. Once a date and time has been decided upon, we will send out a save the date.

SPEAKERS BUREAU. We have been receiving a great number of requests for presentations. In an effort to accommodate those requests and to encourage engagement, the Speakers Bureau will provide an opportunity for staff to get involved as a presenter, creator of presentation materials, other capacity in accordance with their interests and skill set. We sent out an email to determine the level of interests and learned that there are several members of the staff who are interested. Accordingly, we are currently developing the format for the Bureau and will commence the program once the format has been finalized.

ALTERNATIVE MEETING SITES *revisited*. Previously, the Commission discussed having meetings at Akron and Wright State. We discussed having a Commission meeting at Wright State University in the Spring. The Commission can have a meeting in Akron again this year in the fall. The Commission should commence scheduling these two meetings for this year.

DR. MARTIN LUTHER KING, JR. ART, ESSAY, and MULTI-MEDIA CONTEST. This event was held on *February 23, 2023*, The Executive Director of the Ohio History Connection, Megan Wood, was our keynote speaker who congratulated the winners for their accomplishments. She also shared the work of the Ohio History Connection. She expressed the importance of preserving Ohio's history through artifacts and historical sites throughout the state of Ohio.

CASE MANAGEMENT SYSTEM. The process is moving forward.
