## **GENERAL**

ADA PROCEDURE AND PROCESS. DAS has required that state agencies develop an ADA reasonable accommodation request and appeal process for employees and for the public seeking to access the services of the Commission. The ADA Coordinator and the General Counsel developed the ADA procedure and process to be in compliance with DAS requirements. The request and appeal procedures for the employees were disseminated to the staff. The Title II procedures and process for the public were placed on the website. In addition, training is being created for the staff, also pursuant to a mandate from DAS.

OHIO ADMINISTRATIVE CODE. Bradley Dunn and Mary Turocy attended the JCARR meeting on March 27, 2023. The final rules were filed and will take effect April 11, 2023. Our next package of rules, which encompasses rules where there were no changes other than adding that they amplify Ohio Revised Code 4112.051 has a public hearing scheduled for April 14, 2023. Training on the changes will be scheduled to enlighten the staff of the rule changes.
