I. INTRODUCTION

Background

In November 2023, Ohio voters approved a citizen-initiated statute to legalize the possession, sale, and use of non-medical cannabis. That initiated statute established the Division of Cannabis Control (“Division” or “DCC”) within the Ohio Department of Commerce and requires the Division to issue applications for non-medical cannabis license by June 7, 2024, and issue licenses by September 7, 2024.

The initial licenses required by the initiated statute include:

1. Non-medical cannabis licenses for each current medical marijuana cultivator, processor, testing laboratory, and dispensary licensed pursuant to O.R.C. 3796, at the same location which they are currently operating. These licenses are referred to throughout these materials as “applications to convert a medical marijuana license” or “dual-use” licenses.
2. Additional dispensary licenses for new locations allocated to each current medical marijuana cultivator, as well as dispensaries that are not commonly owned or controlled by a cultivator or processor. These are referred to as “10(B) applications” or “10(B) licenses.”

This packet is for applications to convert a medical marijuana license to a dual-use license.

Each current medical marijuana cultivator, processor, testing laboratory, and dispensary that wishes to participate in the non-medical cannabis market at their current location must apply for a dual-use cannabis license.

No one is permitted to cultivate, process, test, or sell non-medical cannabis until a dual-use license Certificate of Operation is issued.

Legal Authority

Applicants are advised to review Chapter [3796](#) and [3780](#) of the Ohio Revised Code (O.R.C) as well as Chapter [3796](#) and proposed [1301:18](#) of the Ohio Administrative Code (O.A.C.), and seek legal counsel where necessary.

Applications will be reviewed in the order in which complete applications are received. To help ensure supply chain efficiencies, cultivator, processor, and testing laboratory applications will be processed with priority.

All requirements outlined below and in subsequent communication from the Division must be met before a dual-use Certificate of Operation will be issued.

Communication

After an application is submitted, all communications from the Division will be directed to the individual listed as the primary point of contact on the application.

II. APPLICATION MATERIALS AND SUBMISSION

Application Materials

The Division will post the application, when available, on the website listed above. Please see Appendix A for a list of questions and information that will be required for submission on the application.

The complete Dual-Use Application packet includes:

- Fillable PDF Application document
- Dual-Use Applicant Attestation
- Tax Authorization Form

Completing an Application

For an application to be considered complete, you must complete each question of the fillable PDF document and submit the completed Dual-Use Applicant Attestation and Tax Authorization Form.

FORMAT: The completed fillable PDF application must be saved with the file name *“Business Name – MMCP License Number – Dual-Use License Application.”*

The completed and signed attestation must be saved in PDF format with the file name *“Business Name – MMCP License Number – Dual-Use Application Attestation.”*

The completed and signed Tax Authorization Form must be saved in PDF format with the file name *“Business Name – MMCP License Number – Dual-Use Application Tax Authorization Form.”*

The signed Dual-Use Applicant Attestation and Tax Authorization Form must be scanned. Photographs of the completed forms are **not** acceptable.

Additional information or documentation may be attached. All documents responding to a single question must be combined into a single file. The contents of attachments must be clear and visibly labeled. All attachments must be saved with the naming convention *“Business Name – MMCP License Number – Question Number.”*

All three documents of the required application packet as well as any additional documentation must be submitted together, at one time, for the application to be considered complete.

A separate application is required for each facility license.

For example: If you have a cultivator, processor, and two dispensary licenses, you will need to submit an application for your cultivator, an application for your processor, and two separate applications for your two dispensary licenses.

Submitting an Application

On Friday, June 7 at 8:00am ET, the Division will begin accepting applications to convert a current medical marijuana license to a dual-use license. The complete application and related materials may be submitted in one of two ways. The instructions below must be followed for an application submission to be considered:

Option 1:

- Email the complete application packet to DCCApplications@com.ohio.gov with the subject line “*Business Name – MMCP License Number – Dual-Use Application.*” This email address can accept up to 150 MB of attachments.

OR

Option 2:

- Step 1: Drop the complete application packet in the State of Ohio File Drop here: <https://filedrop.cloudfs.ohio.gov/>.
 - Must enter the recipient email as DCCApplications@com.ohio.gov.
- Step 2: Email DCCApplications@com.ohio.gov **after** submitting your files, with the subject line “*Business Name – MMCP License Number – Dual-Use Application,*” and indicate that your files have been submitted in the File Drop.

You will receive an automatic response from DCCApplications@com.ohio.gov that your email has been received. If you do not receive this response, check your “junk” or “spam” folder.

Applications will not be accepted in any other form of submission, including any other file share, file drops, or FTPs.

There is no deadline to submit a dual-use license application. However, applications will not be reviewed until a completed application is received.

There is no fee associated with an application to convert a current medical marijuana license to a dual-use license.

III. APPLICATION REVIEW

Provisional License

The Division will review applications in the order in which complete applications are received.

If an application is incomplete, the Division will notify the applicant of the deficiencies and the applicant will be provided with 10 business days to cure the deficiencies and submit the complete application packet again.

The application will not be reviewed until all required information is submitted.

Upon submission of a complete application (see Section II above), a provisional license will be issued via DCC eLicense. Your provisional license will then be accessible within your eLicense Account to your eLicense Account Administrators and Account Managers.

A provisional licensee is not permitted to sell non-medical cannabis.

Certificate of Operation

Below is a list of items the Division will review to ensure compliance prior to issuing a Certificate of Operation.

After obtaining a Certificate of Operation, all dual-use cannabis licensees must comply with O.A.C. 3796 and all conditions placed on licensure until all rules are effective under O.A.C. 1301:18, unless otherwise specified by the Division.

A. Individual Badging and Background Checks

All employees, agents, owners, officers, board members, and administrators responsible for the daily operation of the facility must have an active employee badge beginning with “CCE” in DCC eLicense.

A New Employee Application must be submitted in the DCC eLicense portal for all required individuals who either have no active employee badge or whose employee badge begins with “MMCPE” or “MME.”

If the individual does not have an active employee badge currently, they must submit fingerprints for both a BCI and FBI background check. Background check guidance can be found [here](#).

eLicense Instructions

You can view all employees for your facility license(s) within eLicense to readily identify those who need a new CCE badge.

To view all employee licenses for a specific facility, the eLicense portal user will select the Manage Licenses tab. Next, select the down arrow next to the facility license for which you wish to view employees, and click View. Expand the Employee Licenses section.

Affiliating Employees with Facility License

Upon issuance of your dual-use provisional license, an eLicense Account Administrator must access eLicense and affiliate each employee to the new provisional facility license.

A “CCE” employee badge may be affiliated (via the facility relationship function) to each facility license across a “family of companies.”

- Each facility for which an individual is employed, is an agent, owner, officer, or board member, or administers the daily operation, must be affiliated with that employee in DCC eLicense.
- If the individual is an owner or responsible party, such employee type must be designated on the eLicense employee record for each facility that it applies.

All employee affiliations (relationships) must be added to the dual-use provisional facility license(s) before a Certificate of Operation will be issued.

NOTE: Do not unaffiliate your employees from your current medical marijuana license at this point.

B. Point-of-Sale Updates

Each dispensary must demonstrate in a test sale scheduled and monitored by the Division that their point-of-sale system is capable of all of the following:

- 1. Correctly achieving a sale to a medical patient.**
 - a. Transmitting sales to Metrc, including each item sold (price and product identifier), and sales total (after discount and before taxes), and patient identification.
 - i. Ensuring that inventory is correctly deducted from Metrc following a sale.
 - b. Dispensation is properly transmitted to the Prescription Monitoring Program (PMP) Clearinghouse. Ohio’s PMP is the Ohio Automated Rx Reporting System (OARRS).
 - c. Printing the label required pursuant to O.A.C. [3796:6-3-09](#).
- 2. Correctly achieving a sale to a non-medical consumer.**
 - a. Transmitting sales to Metrc, including each item sold (price and product identifier), and sales total (after discount and before taxes). No consumer identification.
 - i. Ensuring that inventory is correctly deducted from Metrc following a sale.
 - b. Sale is NOT transmitted to the PMP Clearinghouse.
 - c. Printing a label with, at a minimum, the following information:
 - i. Dispensary name
 - ii. Dispensary license number
- 3. Assessing the 10% adult-use excise tax on non-medical sales only.**
 - a. Sales tax must be assessed on both medical and non-medical sales.
 - b. Taxes must be calculated independently, each based on the sale price.
 - For example, if the sale price is \$154.00 and the sales tax is 7.00% while the excise tax is 10.00%, the total is \$180.18.

- The sales tax on \$154 is \$10.78 and the excise tax on \$154 is \$15.40 so the total charged to the customer is \$180.18.
- c. Review the Department of Taxation's FAQ regarding applying Sales and Use Tax [here](#).

4. **Printing a sales receipt** that provides, at a minimum, the following information:
- a. Notation that it is a medical or non-medical sale.
 - b. Description of each item sold and the sale price.
 - c. Any discounts credited, list separately.
 - d. Sales tax, listed separately.
 - e. Excise tax, if applicable, listed separately.

In addition to the above, dispensaries are responsible for preventing sales that exceed eligible transaction limits.

- **Non-medical consumers** may not purchase more than ten whole day units of cannabis combined across all forms pursuant to O.A.C. 3796:8-2-04 per day.
 - For example, a non-medical consumer may purchase 1.0 ounces of plant material for vaporization OR ten units of oil for vaporization containing 590mg of THC each OR ten packages of edibles totaling not more than 1100mg of THC total.
- **For medical marijuana patients**, the 90-day supply and whole day unit amounts remain the same under O.A.C. 3796:8-2-04, until updated rules are effective.

In addition to operating procedures to appropriately calculate and dispense days' supply without exceeding a medical marijuana patient's supply limits, the dispensary must have operating procedures in place to not exceed transaction limits for non-medical consumers, as prescribed in the paragraph above.

Dispensaries must also follow the below requirements for accepting returns from both medical patients and non-medical consumers.

- Establish, maintain, and comply with written policies and procedures to accept returned cannabis.
- Each dispensary must accept the following cannabis returned by a patient or consumer:
 - Defective product, which must be destroyed and disposed of by the dispensary in accordance with O.A.C. [3796:6-3-14](#).
 - Product that does not match the item stated on the purchase receipt.
 - Cannabis mislabeled by the cultivator or processor of the product.
 - All cannabis returned to a dispensary due to mislabeling by a cultivator or processor must be reported to the Division via email to DCCompliance@com.ohio.gov.
- A dispensary may accept returns for other reasons so long as the dispensary establishes, maintains, and complies with written policies and procedures for such returns.
- Each dispensary must provide the customer a refund of the purchase price of the product contemporaneously with the return, and, if applicable, revise the patient's days' supply to reflect the returned product.
- The dispensary's return policy must either be printed on each sales receipt or conspicuously posted at each point-of-sale.

C. Surveillance

A provisional licensee must be compliant with the security and surveillance standards published by the Division on February 9, 2024. A Certificate of Operation will not be issued until compliance with these standards is achieved. For licensees who have not received confirmation from the Division that their surveillance system is in compliance, please note any issues must be resolved before a Certificate of Operation will be issued.

D. Standard Operating Procedures

After a provisional license is granted, and as part of the review process for a Certificate of Operation, the Division may request Standard Operating Procedures (SOPs) from applicants.

Dispensaries SOPs must include, in addition to all requirements in O.A.C. Chapter 3796, procedures to ensure the following:

- Compliance with all point-of-sale requirements for both medical patients and dual-use consumers as discussed above.
- Prevention of sale to or access by individuals under the age of 21, unless they are a medical marijuana patient.
 - Reporting of any sale to or access by individuals under the age of 21 to the Division.
- Visitor logs are maintained appropriately for visitors to a facility who are going to access areas other than the public retail floor. These visitors must be escorted in those non-public areas by an employee.
- Safe flow of traffic throughout the dispensary.
- Safe and efficient curbside pick-up and drive-through windows.
- Serving and accommodating medical patients and caregivers and non-medical consumers alike.
 - Ensuring ongoing inventory sufficient to maintain an adequate supply of medical marijuana to meet the current demand and projected patient and caregiver population.
 - Providing accommodations to medical cannabis patients and caregivers.
- Any discounts provided are in compliance with the following:
 - A dispensary may offer discounts in accordance with a written discount policy and ensure any discount offered to an adult-use consumer or a registered employee of a licensed entity must also be offered to the following individuals:
 - All individuals who are veteran or indigent status; and
 - All registered patients and caregivers.

Cultivators and processors SOPs must be in line with Ohio Revised Code 3796 and Ohio Administrative Code 3796.

E. Compliance & Inspections

To receive a dual-use Certificate of Operation, the current medical marijuana license and facility must be in compliance with all program rules and complete the following.

Outstanding Items

Any outstanding deficiencies must be resolved. Any outstanding fees must be paid.

Changes of ownership must be submitted and approved by the Division.

Variances, changes of operation, or major modifications may need to be complete before a Certificate of Operation for dual-use licensure can be granted.

Renewal

Medical marijuana licenses issued pursuant to O.R.C. 3796 for cultivators, processors, and testing laboratories currently expires annually on the date that it was issued. Chapter 3796 of the Ohio Administrative Code requires that a facility Renewal Application, along with the applicable fee, be submitted within the [eLicense Portal](#) **at least 30 days prior to the date that the Certificate of Operations expires.**

Applicants must be in compliance with all renewal requirements prior to the issuance of a dual-use Certificate of Operation.

Tax Review

A tax review must be completed by the Department of Taxation and any outstanding tax debt must be resolved before a dual-use Certificate of Operation can be granted.

Financial Responsibility

A dual-use license will be issued in place of the previous medical license. Therefore, commercial liability insurance and any bond or escrow requirements as well as any previously approved reduction requests are the same. A dual-use licensee does not need a separate bond for medical and non-medical purposes; however, it is the licensee's responsibility to ensure that the bond or escrow is effective for both medical and non-medical cannabis.

Applicants must be in compliance with financial responsibility requirements prior to the issuance of a dual-use Certificate of Operation.

System Tests

Tests will be conducted on each dispensary point-of-sale system to ensure compliance with the requirements discussed above. Compliance inspectors may conduct these tests virtually or in-person.

Additionally, all licensees will be required to test and confirm Metrc functionality.

Inspections

A facility inspection may be conducted before a dual-use Certificate of Operation can be issued. If a physical inspection is necessary, a compliance inspector will contact you to schedule the time required.

F. Training

To receive a dual-use Certificate of Operation, each dispensary must train their staff on all applicable requirements for dual-use sales. The following must be documented, and records maintained:

- Date of training
- Names of all employees trained
- Brief outline and description of training content

G. DCC Meeting

The controlling interest holder(s), at a minimum, of each dual-use provisional license will be required to attend a meeting with the Division of Cannabis Control.

The meeting may be conducted in-person or via Microsoft Teams. The Division will endeavor to accommodate reasonable scheduling requests; however, a dual-use Certificate of Operation will not be issued until this meeting is complete.

H. Conditions on a Dual-Use Cannabis License

All dual-use cannabis licensees must comply with O.A.C. 3796 and all conditions placed on licensure until rules are adopted under O.A.C. 1301:18, unless otherwise specified by the Division. No dual-use provisional license will be granted a Certificate of Operation without agreeing to comply with this and any other conditions outlined by the Division in subsequent communication.

License Number Assignment & Expiration Dates

Your dual-use license number will be different than your current medical marijuana license number. However, upon issuance of a dual-use Certificate of Operation, the Metrc history for the corresponding medical marijuana license will be maintained under the new dual-use license number. Additionally, eLicense Account Administrators will maintain access to the inactivated medical marijuana license.

All licenses will be set to expire based on the date of the medical marijuana license issuance. This will result in a new expiration date for dispensaries, beginning in 2026. Renewal timeframes for dual-use licenses will be as follows:

- Cultivators: annually
- Processors: annually
- Testing Laboratories: biennially
- Dispensaries: biennially

IV. DISCLOSURE OF APPLICANT INFORMATION

The Applicant understands that the Department of Commerce, Division of Cannabis Control is an entity of the State of Ohio and any documents or data submitted to the State of Ohio may be disclosed by the State pursuant to an Ohio Public Records Act request.

While the Ohio Public Records Act permits certain exclusions from disclosure, Applicant understands the State makes no guarantee or promises that such data will not be disclosed. Applicant has reviewed the Ohio Public Records Act, as well as relevant case law.

Applicant understands that the documents or data it provides to the State of Ohio may not be confidential, or if confidential, may or may not be disclosed pursuant to an Ohio Public Records Act request.

Applicant understands that there are additional requirements in order to claim a trade secret or infrastructure record exception. Applicant understands that materials consisting of trade secrets or infrastructure records must be clearly marked, specifying the pages of the application submission that are to be restricted and justifying the trade secret designation or infrastructure designation for each item.
