

Packaging & Labeling Attestation For Single Serving Units

Pursuant to the guidance issued by the Division of Cannabis Control (DCC or Division) on August 1, 2025, templates were provided to processors for the purposes of packaging and labeling raw and infused single serving units.

All packaging and labeling is required to be submitted via the Packaging & Labeling Application in DCC eLicense. Please submit only one package per application.

- Prior Approval Required: If you are not utilizing any of the templates provided by the
 Division in the guidance or only utilizing a template for portions of packaging and
 labeling, your application must be approved by the Division prior to use.
 - If you are utilizing any templates provided in the guidance, you must submit the following:
 - For the packaging upload, include all renderings of your packaging and if you are utilizing only the elements detailed in the guidance under Section D for packaging, also upload this form.
 - For the labeling upload, include your label template and if you are utilizing the standard label template identified in Section F for labeling, also upload this form.
 - For child-resistance and tamper-evidence uploads, if you are utilizing one of the packages or tamper-evident mechanisms exactly as listed in the guidance, please provide *only* this form in the child-resistant and tamper-evidence upload section of the application.
- Prior Approval Not Required: If you are utilizing the templates provided in the guidance only, you are required to submit a Packaging & Labeling application but do not have to wait for approval prior to use. In place of the child-resistant and tamper-evidence uploads within the packaging and labeling application you must submit this form. To qualify for this exception, this means you are utilizing only the following for your packaging and labeling:
 - The permitted advertising elements detailed in the guidance under Section D for your packaging.
 - The standard label template identified in the guidance under Section F for labeling.
 - One of the child-resistant packages and tamper-evident mechanisms exactly as listed in the guidance.

Licensee hereby agrees to all of the following:

- 1. The present application constitutes a true, accurate, and complete representation of all information, documentation, and attestations of Licensee as of the date of execution of this Attestation;
- Licensee has a duty to immediately notify the Ohio Division of Cannabis Control in writing of any changes or modifications to the information provided in this application, which may result in rescission or amendment of Licensee's approval to produce single serving units;
- Licensee shall package and label single serving units, both raw and infused, only in the manner as provided and asserted by Licensee within this application. Any modifications to packaging or labeling must be submitted separately;
- 4. Licensee shall adhere to all present and future guidance and directives issued by the Division, either directly to Licensee or as published and required by all cannabis operators licensed by the Ohio Division of Cannabis Control;
- 5. Licensee shall adhere to all applicable requirements outlined under Chapters 3780 and 3796 of the Ohio Revised Code, and Chapters 1301:18 and 3796 of the Ohio Administrative Code, including, but not limited to: advertising, packaging, and labeling;
- 6. Licensee understands that the Division's approval of this Application is based solely upon the information, documentation, and assertions, as provided by Licensee in this application and as submitted to the Division;

- 7. Division approval of this Application does not constitute a waiver of any violations of Chapters 3780 and 3796 of the Ohio Revised Code, Chapters 1301:18 and 3796 of the Ohio Administrative Code, this application, or the guidance the Division issued on August 1, 2025;
- 8. Licensee understands in the event the Division determines Licensee is in violation of the regulatory requirements outlined in paragraph 7 above, the Division reserves the right to investigate and proceed with any action authorized under Chapters 3780 and 3796 of the Ohio Revised Code and Chapters 1301:18 and 3796 of the Ohio Administrative Code, including amendment or revocation of Licensee's approval of the present application, commencement of a formal enforcement action, issuance of a civil penalty, or suspension or revocation of the underlying license to operate;
- 9. Licensee understands that it shall be solely liable for any underlying deficiencies, concerns, or misrepresentations of the information, documentation, and assertions provided within the present application, including, but not limited to, all specifications pertaining to child-resistant packaging, as outlined under 16 CFR 1700.15 and 16 CFR 1700.20, and all associated test data;
- 10. Licensee obtained legal counsel where necessary to review the present Attestation in furtherance of the present application to produce single serving units in accordance with the guidance issued on August 1, 2025; AND
- 11. Licensee understands that unless and until the Division determines the present application meets all requirements to manufacture, advertise, package, label, test, and distribute single serving units and provides written authorization to proceed, Licensee shall not manufacture, produce, distribute, or sell single serving units.
