LIST OF POTENTIALLY DISQUALIFYING OFFENSES

An applicant to the Division of Securities (the Division) for a license or certificate that has pleaded guilty to, been convicted of, or been found guilty of any of the following crimes **may be disqualified** from being licensed as an investment adviser, investment adviser representative, dealer, securities salesperson, bureau of workers' compensation chief investment adviser, and/or state retirement system investment adviser. Please review these Sections of the Ohio Revised Code (ORC) and the United States Code (USC) as they may be amended, modified, or removed from time to time.

The crimes listed below also include (i) a violation of any existing, former, or future ordinance, law, judicial order, or other legal obligation imposed by any municipal, state, federal, or administrative jurisdiction, that is substantially equivalent to any section, division, or offense listed below, and (ii) a conspiracy to attempt or commit, or complicity in committing any section, division, or offense listed below.

The following crimes are considered by the Division to be directly related to the duties/responsibilities of the licensed occupations:

Review of Applicant's Offense History by the Division

The above listed crimes are not automatically disqualifying. The Division reviews the facts of each applicant's case on an individual basis. The offense may or may not result in a proposed action to deny licensure. The factors considered may include, but are not limited to, the following:

- The nature and seriousness of the offense;
- Passage of time since the crime was committed and whether the sentencing requirements ordered by the court were successfully completed;
- Whether any other offenses were committed since the crime;
- Relationship of the crime to the ability, capacity, and fitness required to perform the duties and responsibilities of the occupation;
- Any evidence of mitigating rehabilitation or treatment successfully completed, including whether a certificate of qualification for employment under ORC § 2953.25, or of achievement or employability under ORC § 2961.22, has been obtained; and
- Whether denial of the license is reasonably necessary or appropriate in the public interest or for the protection of investors.

The Division does not have the authority to investigate an individual who has not applied for a license. If an applicant has a criminal history, the Division conducts a thorough investigation and considers the above factors and others, including the facts and circumstances involved in the offense, and the total number and pattern of offenses.
