Property and Dormancy Warning

*IN03 & IN04

The proceeds of life insurance policies become dormant and subject to unclaimed funds reporting requirements three (3) years after the date of death of the insured as evidenced by the Social Security Death Index, or three (3) years after the life insurance policy has matured and the proceeds payable if the policy was in force when the insured reached the limiting age under the mortality on which the reserve is based, whichever occurs first. To identify dormant proceeds of life insurance polices the holder should match life insurance policies, annuities and other assets against the Social Security Death Index (SSDI) to identify deceased owners and perform a review to identify insured parties that have reached the limiting age under the mortality table on which the reserve is based annually.

**SC19

The five (5) year dormancy period commences from the date a second shareholder notification or communication mailing to the owner of the funds is returned to the holder as undeliverable by the US Postal Service. The notification or communication mailing by the holder shall be no less frequent than

quarterly. If the mailing is less frequent than quarterly the account would be dormant five (5) years after the date of last customer generated activity.
