Documents Required of ALL Businesses

<input type="checkbox"/>	2. Last tax year's State of Ohio tax return (Ohio IT 1040 or IT1040EZ) for the at least 51 percent owner(s) or Ohio Residency Affidavit
<input type="checkbox"/>	3. Bank Signature Card or A letter, on the bank's letterhead, explaining who has signature authority for the company's bank accounts
<input type="checkbox"/>	4. Personal federal tax returns of the at least 51 percent owner(s) (Form 1040, 1040A, or 1040EZ) for the last three tax years and W-2s and/or 1099s for the at least 51 percent owner(s) and spouses for the last three tax years
<input type="checkbox"/>	5. Business taxes including Schedule K-1 and/or Form 1065, 1120, or 1120S or Schedules C or C-EZ for the last three years or the life of the company (whichever is shorter)
