Ohio Exports 2023

Executive Summary

Ohio merchandise exports were valued at \$55.8 billion in 2023, a decrease of 1.8 percent from 2022. By comparison, the United States experienced a decrease of 2.2 percent in exports since 2022.

According to this report, in 2023:

- Ohio was the 10th largest exporting state.
- 210 countries and territories received exports from Ohio.
- 10 countries received more than \$1 billion in Ohio exports.
- 43 of the 98 commodity groups recorded exports exceeding \$100 million with 15 surpassing \$1 billion.

Leading Destinations:


- Exports to Canada totaled \$21.4 billion, 38.4 percent of the state figure. By comparison, U.S. exports to Canada made up 17.5 percent of the national total.
- Shipments to Mexico, Ohio's second largest market, totaled \$8.3 billion. This figure is an increase of 12.8 percent from 2022.
- Asian countries were recipients of 12.1 percent of Ohio's shipments. China was Ohio's third largest market at \$2.8 billion, a decrease of 5.2 percent. Japan was Ohio's fourth largest market in 2023 at \$2.1 billion.
- European countries accounted for 14.8 percent of Ohio's exports. The four largest European markets were United Kingdom (\$1.9 billion), Germany (\$1.4 billion), France (\$1.2 billion), and the Netherlands (\$1.0 billion). Total shipments to Europe decreased 9.1 percent from 2022.
- Exports to Southeast Asia accounted for 6.7 percent (\$3.7 billion) of the state figure, an increase of 14.4 percent. Exports to the Middle East and Africa both saw a large annual decrease of 14.2 percent and 47.3 percent, respectively.

Top Products:

- Industrial machinery was Ohio's leading export (\$9.6 billion). Ohio was 5th among the 50 states in this category with 4.1 percent of the U.S. total.
- The top six categories (industrial machinery, vehicles, aircraft, electrical machinery, plastics, and optic/photo/medical instruments) accounted for 57.3 percent (\$32.0 billion) of the state total.
- Ohio leads the nation in exports of soaps/cleaning preparations/waxes (17.3 percent of U.S. total) as well as paints/dyes/putty (9.3 percent of U.S. total).
- Exports of cosmetics/essential oils increased 15.4 percent for the year. Ohio ranked 2nd in cosmetics exports with 11.2 percent of the U.S. total. Pharmaceutical exports dropped 59.9 percent from all-time highs. Exports of oil seeds (soybeans) continued to decline in 2023 falling 50 percent.


Ohio Exports

Employment and Businesses Related to Exports

Goods exported from Ohio supported an estimated 194,100 jobs in 2021. Eighty-eight percent of these jobs were supported by manufactured goods exports.

A total of 15,534 companies exported from Ohio in 2020. Of those, 13,718 (88 percent) were small and medium-sized enterprises with fewer than 500 employees.

Small and medium-sized firms generated 22.7 percent of Ohio's total exports of merchandise in 2019.

The Cincinnati Metropolitan Area had exports of \$29.29 billion in 2022 which led the 13 metropolitan areas in Ohio. This figure represented a 26.2 percent increase over the previous year. Nearly 45 percent, \$13.11 billion, of the exports were in the transportation equipment sector with chemicals a distant second at \$6.9 billion.


The Cleveland-Elyria Metropolitan Area was second in exports at \$9.56 billion, an increase of 11.7 percent since 2021. Chemicals accounted for 18 percent of exports followed closely by fabricated metal products.

Third in exports was the Columbus Metropolitan Area at \$7.60 billion, an increase of 15.8 percent. Thirty percent of the exports, \$2.28 billion, were in the chemicals sector. Transportation equipment accounted for \$712 million.

It should be noted that metropolitan area exports are ZIP code based while the rest of this report is origin state based. While the original source of the data is the same the totals for the state can differ because of how the export declarations are completed.




U.S. Distribution of Ohio's Top Twenty Exports


