PERSONAL INCOME

Contents

Personal income includes income from wages, salaries, net self-employment or proprietor earnings, interest, dividends, rents and transfer payments as well as employee and employer contributions to funds for pensions and government and non-government insurance programs. See the U.S. Bureau of Economic Analysis (BEA) website for more specific details.

These datasets include the aggregate total personal income of all residents (in thousands of dollars) and personal per capita income for the state and 88 counties. Personal per capita income (PCI) is the aggregate total personal income of the residents of an area divided by the resident population. No adjustment for inflation has been made for the counties. However, table 1 includes at the bottom estimates comparing the state and the nation after adjusting for inflation and regional price parities.

Data in this report are presented for the state, the 88 counties, and occasionally the nation. The larger dataset includes data for metropolitan areas, divisions, and regions.


Comparison to Other Datasets






