Minimum Policy Criteria for Funeral Viewing/Deathbed Visits:

Web-based funeral viewing and bedside visits shall be given priority before approving any outside trips. The decision to approve or disapprove a web-based funeral/bedside visit is strictly within the professional discretion of the Warden.

IF THE REQUEST IS DISAPPROVED BASED UPON ANY OF THE ABOVE LISTED FACTORS THEN STOP HERE.

In circumstances where web-based visitation is not available, an escorted visit may be arranged. In addition to the above factors to be considered by the Warden, the following mandatory criteria must be considered for an escorted visit to occur:

- YES NO Does the inmate have three or more felony commitments (including current commitment).
- YES NO Does the inmate have two or more felony commitments for a crime of an assaultive nature (including the current commitment)?
- YES NO Is the inmate Death Row or Security Level 4 or ERH?
- YES NO Does the inmate have a history of an escape within the last ten years?
- YES NO Is the proposed escorted visit outside the state of Ohio?

IF "YES" TO ANY OF THE ABOVE QUESTIONS THE INMATE IS NOT ELIGIBLE FOR AN ESCORTED VISIT.
