Introduction

Where Do Veterans Go to Get Help?

Since 1886, Ohio has provided help for veterans, their spouses and children, and surviving family members of deceased veterans. These services are provided through County Veterans Service Offices in each county. Each office is funded by a portion of the assessed local property taxes to ensure these services are available.

These offices are staffed by certified and accredited service officers to help Ohio's veterans apply for all benefits earned by active military service, which are described in this publication. These benefits include:

- FEDERAL** Disability Compensation, Pension, Healthcare, Education, Home Loans, Burial and Survivor Benefits.
- STATE** Veterans Bonus, Education, Employment, Healthcare, Home Loans, Ohio Veterans Homes and Military Injury Relief Fund.
- LOCAL** Claim Preparation & Assistance, Financial Assistance, Transportation to VA medical appointments and Indigent Burials.

Veterans' spouses and other survivors may be eligible for federal and state benefits. County Veterans Service Offices can provide information and advocacy concerning these benefits and will assist with the application process.

Introduction

Where Do Veterans Go to Get Help?

Each County Veterans Service Office will assist veterans or their families with financial emergencies. This short-term assistance varies with the individual abilities of each county.

Such assistance may include payment of rent, mortgage, food, utilities, car payment or insurance.

An application process is required in all counties.

For details concerning the level of financial assistance and transportation available in a specific county, check with your local County Veterans Service Office.

Veterans are also encouraged to record their discharges (DD-214s) at their County Recorder's office.

This provides a duplicate record if a certified copy is needed as verification for veterans benefits.

Many County Veterans Service and County Recorders offices make Veteran ID cards.

The U.S. Department of Veterans Affairs (VA) has established a national Veterans Crisis Line to ensure that veterans have free, 24/7 access to trained counselors. To operate the hotline, the VA partnered with the Substance Abuse and Mental Health Services Administration (SAMHSA) and the National Suicide Prevention Lifeline. Veterans, family members and friends can call the lifeline number by simply dialing 988 and then pressing 1. The old number, 800-273-TALK (8255), also will remain available for use. All calls are confidential and are routed to the hotline where callers can speak to counselors (familiar with military experience) about any issue that is creating a life crisis situation. The Crisis Line also can be accessed via text or chat.

GI Bill®

The GI Bill®, which helps pay for higher education and training programs, is the federal government's primary educational program for veterans.

- The Post-9/11 GI Bill® is for individuals with at least 90 days of aggregate service on or after Sept. 10, 2001, or individuals discharged with a service-connected disability after 30 days. You must have received an honorable discharge to be eligible. The Post-9/11 GI Bill® became effective for training on Aug. 1, 2009. In addition to traditional degree-granting programs, the Post-9/11 GI Bill® was expanded on Oct. 1, 2011 to include on-the-job training, non-college degrees, flight training, apprenticeships and correspondence.
- There are two versions of the Montgomery GI Bill ® Program: Chapter 30, which is available to service members for 10 years and Chapter 1606, which has a 14 year window. Each provides up to 36 months of education benefits. You must have received an honorable discharge to be eligible. This benefit may be used for degree and certificate programs, flight training, apprenticeship/on-the-job training and correspondence courses. Remedial, deficiency and refresher courses may be approved under certain circumstances.

Fast Track to College Credit for Veterans

If you have served in the U.S. Armed Forces or National Guard, your training, experience and/or coursework may translate to college credit. Military Transfer Assurance Guides (MTAGs) provide a statewide guarantee that certain types of military training, experience and/or coursework align to existing college and university courses and will be awarded appropriate credit.

Ohio GI Promise

Ohio GI Promise authorizes the Chancellor of the Ohio Department of Higher Education to deem qualified veterans as Ohio residents for the purpose of qualifying for in-state tuition rates.

The Residency Officer at each public institution has sole authority to request any documentation in order to make the final determination of residency status.

War Orphans & Severely Disabled Veterans' Children Scholarship

The Ohio War Orphans & Severely Disabled Veterans' Children Scholarship program provides tuition assistance to children of killed-in-action (KIA) or at least 60-percent VA-rated service-connected disabled Ohio veterans who served in the U.S. Armed Forces during a period of declared war or conflict.

Deadline: May 15.

Eligibility:

- Veteran parent must be KIA or at least 60-percent VA-rated service-connected disabled.
- Student must be enrolled for full-time undergraduate study at an eligible Ohio college or university.
- Ohio residence is required and applicant must be under 25.

Ohio Safety Officers College Memorial Fund

This fund provides a tuition waiver for children of members of the U.S. Armed Forces who were killed in the line of duty during OEF or OIF or a combat zone designated by the President of the United States.

Tuition waivers are also available (for up to four years of undergraduate education) for the spouse or qualified former spouse of a member of the U.S. Armed Forces killed in the line of duty while serving in a combat zone after May 7, 1975.

Eligibility:

- Spouse must be an Ohio resident at the time the member was killed.
- Need a "Report of Casualty" DD Form 1300.

Ohio National Guard Scholarship Program

This scholarship covers 100 percent of tuition charges for courses applicable to, or leading to, an associate or bachelors degree, a diploma-granting nursing program, as well as approved trade certification, credential-certifying or licensing programs at participating public colleges and universities.



Eligibility:

- Complete a three- or six-year enlistment in the Ohio Guard.
- Must be in good standing.

High School Diploma

School district/city boards of education may grant a high school diploma to any veteran of WWII, the Korean War or Vietnam War, or to women who left school to support the war effort.

If a person who qualifies for a diploma under this program is deceased, the diploma may be awarded posthumously.

Eligibility:

- Veteran left school prior to graduation to serve in the U.S. Armed Forces or left school prior to graduation due to family circumstances and subsequently entered the Armed Forces.
- Veteran has not been granted a diploma.
- Veteran received an honorable discharge.
- A woman left school prior to graduation in order to join or subsequently join the workforce to support her family or to join the work effort.

USERRA – Uniformed Services Employment & Re-employment Rights Act

This act is intended to ensure that persons who serve or have served in the U.S. Armed Forces, Reserves, National Guard or other “uniformed services” are: not disadvantaged in their civilian careers because of their service; promptly re-employed upon their return from duty, and are not discriminated against in employment based on past, present or future military service.

Homeowners Assistance Program (HAP)

The Department of Defense Homeowners Assistance Program (HAP) assists eligible homeowners who face financial loss when selling their primary residence homes in areas where real estate values have declined because of a base closure or realignment announcement.

HAP is based upon the Demonstration Cities and Metropolitan Development Act of 1966, and was expanded by the American Recovery and Reinvestment Act of 2009. HAP consists of BRAC impacted personnel or wounded, injured or ill and surviving spouse applicants.

Home Energy Assistance Program (HEAP)

HEAP is an Ohio Development Services Agency program that exists to help low-income Ohioans pay their utility bills.

Eligibility:

HEAP is a federally funded program designed to assist eligible low-income Ohioans with their winter heating bills. Households may be eligible for assistance from HEAP if the household's income is at or less than 175 percent of the federal poverty guidelines. If you are eligible, the amount of your benefit will depend on federal funding levels, how many people live with you, your total household income and the primary fuel you use to heat your home. In most cases, benefits will be a credit applied to your energy bill by your utility company. Emergency HEAP also may be available.

Medical Facilities

The Veterans Health Administration is home to the largest integrated healthcare system consisting of more than 150 medical centers, in addition to numerous community-based outpatient clinics, community living centers, Vet Centers and Domiciliaries. Together, these healthcare facilities provide comprehensive care to veterans in Ohio and nationwide.

VHA Medical Centers provide a wide range of services including traditional hospital-based services such as surgery, critical care, mental health, orthopedics, pharmacy, radiology and physical therapy.

In addition, most of the medical centers offer additional medical and surgical specialty services including audiology and speech pathology, dermatology, dental, geriatrics, neurology, oncology, podiatry, prosthetics, urology and vision care. Some medical centers also offer advanced services such as organ transplants and plastic surgery.

Vet Centers

Vet Centers understand and appreciate veterans' war experiences while assisting them and their family members toward a successful post-war adjustment in or near their community. The VA provides mental health counseling for veterans and families at seven Vet Centers in Ohio.

Vet Center staff provide military sexual trauma (MST) and bereavement counseling to individuals, groups and families. Services include treatment for any military-related issues that affect functioning within the family, work, school or other areas of everyday life. Other services include outreach, education, medical referral, homeless veteran services, employment, VA benefit referral and coordination with local providers. These services are a critical link in the overall healthcare available to veterans.

PACT Act

The PACT Act is a federal law that expands VA healthcare and benefits for veterans exposed to burn pits, Agent Orange and other toxic substances.

The full name of the law is The Sergeant First Class (SFC) Heath Robinson Honoring our Promise to Address Comprehensive Toxics (PACT) Act, and is named after a former Ohio Army National Guard veteran who passed away on May 6, 2020.

The PACT Act provides well-deserved aid to generations of veterans and their survivors. It was expanded in March 2024, making benefits available to millions of veterans, including those from the Vietnam, Gulf War and Post-9/11 eras. It also includes the Camp Lejeune Justice Act, which can provide compensation to veterans who experienced water contamination on that base.

However, there is some confusion and misinformation in the veteran community with regard to PACT Act benefits. Veterans have options, but are strongly encouraged to reach out to either your local County Veterans Service Office (see listing beginning on page 5) or directly contact a VA representative.

VA Home Loan Guaranty

Veterans who have completed 24 months of continuous active duty and have been discharged under conditions other than dishonorable or who are currently serving on active duty or in the National Guard or the Reserves or are honorably discharged from these components are eligible for guaranteed loans to purchase, repair or refinance a home.



Based on purchase price and local limits, a down payment may not be required. Eligibility is also extended to unremarried surviving spouses. Periods of required service are less for veterans of earlier wartime service.

Service-Connected Injury/ Disability Compensation

Injury or disability compensation is a monetary benefit paid to veterans who are disabled by an injury or disease that was connected with active military service.

- Disability compensation varies with the degree of disability and the number of dependents, and is paid monthly.
- Veterans with certain severe disabilities may be eligible for additional special monthly compensation.
- The benefits are not subject to federal or state income tax.
- The payment of military retirement pay, disability severance pay and separation incentive payments known as Special Separation Benefits (SSB) and Voluntary Separation Incentives (VSI) affects the amount of VA compensation paid.

To be eligible, the service of the veteran must have been terminated through separation or discharge under conditions other than dishonorable.

- Upon renewal of a driver's license, all Ohio veterans with a valid DD-214 or other relevant official military documentation can receive a free "Armed Forces" stamp on their license, which can qualify them for retail discounts.

Burial and Memorial Benefits

Burial in a national cemetery is available to veterans of active federal military service, their spouses and dependent minor children. Provided at no cost to the family, a national cemetery burial includes:

- The gravesite and grave-liner.
- Opening and closing of the grave.
- A headstone or marker.
- Perpetual care as part of a national shrine.

If a veteran is buried in a private cemetery anywhere in the world, the VA will provide a headstone or marker.

In addition, a burial flag is available to drape the veteran's casket or urn during the funeral. Presidential Memorial Certificates honoring the veteran may be requested.

Military funeral honors for the veteran include burial flag folding and presentation of "Taps" played on a bugle or by recording. Funeral directors usually can arrange for these specific services on request.

Military Injury Relief Fund

The fund grants up to three separate tax-exempt monetary payments to military service members diagnosed with a combat-related injury as a member of the U.S. Armed Forces while serving after Oct. 7, 2001 and to individuals diagnosed with post-traumatic stress while serving after Oct. 7, 2001.

Eligibility:

- Documentation of the awarding of the Purple Heart in accordance with Title 10, Ch.57 of the U.S. Code, Ch.32 of the Code of Federal Regulations and other applicable federal laws.
- Documentation of the combat-related injury and documentation showing that this injury resulted in awarding of a Combat Infantryman Badge (CIB), Combat Action Ribbon (CAR) or Combat Action Badge (CAB) or its equivalent.
- Documentation of a combat-related injury not covered above, primarily including but not limited to traumatic brain injury, injury caused by detonation of an improvised explosive device (IED) or post-traumatic stress (PTS). Documentation of PTS must include medical diagnosis.

Military Ready to Vote/ I Vote in Honor of a Veteran

Veterans Pension Program

Description:

The Veterans Pension program provides monthly payments to wartime veterans who meet certain age or disability requirements, and who have income and net worth within certain limits. Payments are made to bring the total income, including other retirement or Social Security, to a level set by Congress. In addition, the VA Survivors Pension offers monthly payments to qualified surviving spouses and unmarried dependent children of wartime veterans.

Eligibility:

- Veteran must not have received a dishonorable discharge.
- Veteran must have 90 days or more of active military service, at least one day of which was during a wartime period.
- Veteran who entered active duty on or after Sept. 8, 1980, or officer who entered active duty on or after Oct. 16, 1981, may have to meet a longer minimum period.

Homestead Exemption

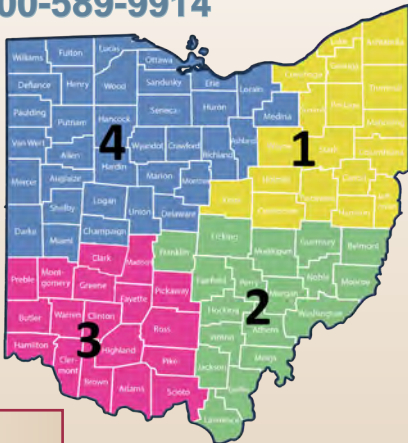

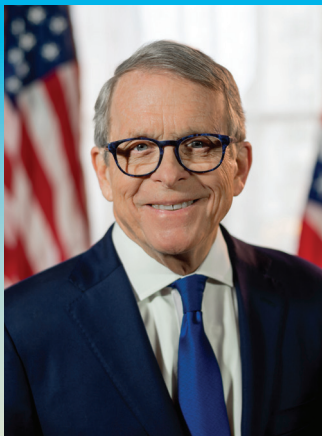

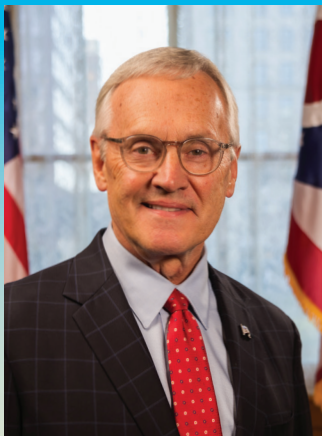
