## 2) Reciprocity Applications

Andrew Bartee has held his Drinking Water Treatment Class IIIA and Water Distribution Class IID license with the State of Kentucky since 04/28/2023 and 02/26/2024. Kentucky's lowest licensure is a Class I and their highest is a Class IV. Mr. Bartee took a State of Kentucky's examination previously reviewed by Council. It was determined that Kentucky's examination is one classification lower than Ohio. Mr. Bartee currently has 62 months of experience.

Andrew Herendeen has held his Class D-2 Waterworks Operator license with the State of Michigan since 11/2/2021. Michigan's lowest licensure is a Class 5 and their highest is a Class 1. Mr. Herendeen took a State of Michigan's examination previously reviewed by Council. It was determined that Michigan's Class D-2 examination is equivalent to an Ohio Class 2. Mr. Herendeen currently has 35 months of experience.

Matthew Perez has held a Water Distribution Class 3 with the State of Arizona since 8/19/2024. Arizona's lowest Wastewater Treatment certification is a Class 1 and the highest is a Class 4. Mr. Perez took the Level 3 Water Distribution Examination through WPI/ABC. The WPI/ABC Class 3 Water Distribution Exam is the equivalent of an Ohio EPA Class 2 Water Distribution license. Mr. Perez has 48 months of Water distribution experience.

James Gellner made a motion to recommend the Director issue a Class 2 Water Supply license to Andrew Bartee and Andrew Herendeen, and issue a Class 2 Water Distribution license to Matthew Perez. Todd Hone seconded the motion. Motion carried.
