FUTURE CONSIDERATIONS FOR MMAC

- 42 month updates to District Solid Waste Management Plans are not necessary. The only benefit is for consultants who literally write the same plan 3 times. Our District could save over \$100,000 if 15-year plans were actually 15-year plans.
- The Covid Pandemic placed SWMD operations as Essential Services while others in government are not back to work three years later. All of the enforcement criteria for SWMWs stayed in effect. This needs to be looked at.
- The cost of labor, fuel, and equipment has increased 50% since March 2019. It is nearly impossible to provide hard quotes for materials, equipment, and services 6 months in advance of DEFA grant deadlines.
