


Recycling and Litter Prevention Grants




Virtual Walk-Through

- Scope of visits:
 - Full-service look at all processes
 - Limited-service look at specific operations works best with the virtual process
- Informal training







Virtual Walk-Through

- Employee participation
 - Required for all visits
 - helps assess safety and hygiene management
 - helps assess the extent of the exposure to the hazard
 - For union shops, opportunity to participate in walk-through is required

Industrial Hygiene Services

- Air, noise, ventilation assessments
- Provide advice to the proper industrial hygiene/engineering controls
- Written program reviews
- Questions and answers Anything Health-related
- Conduct noise surveys Temporarily on hold
- Conduct air monitoring Temporarily on hold

Ergonomic injury concerns? There's help for that...

- Workers in many different industries and occupations can be exposed to risk factors at work, such as lifting heavy items, bending, reaching overhead, pushing and pulling heavy loads, working in awkward body postures and performing the same or similar tasks repetitively
- <u>Musculoskeletal disorders (MSDs)</u> affect the muscles, nerves, blood vessels, ligaments and tendons

Construction companies

- Provide assistance to both small contractors and large ones (less than 250 Employees)
- Subcontractor or General Contractor- we can assist both
- General contractor visit includes all subs under their control
- Subcontractor must ask GC for permission for our visit
- Informal training on focus four issues

Opening Conference

- Rights and obligations explained
 - Hazard correction timelines and
 - Interim protection measures are agreed to.
- Limited service consultation that addresses your needs
 - Virtual walk-through
 - Written program review
 - Review of OSHA recordkeeping (300 logs)
 - Safety and health management assessment

Hazards Identified

- Imminent danger situation
 - abated immediately
- Serious finding
 - Develop and agree to a reasonable plan and schedule to eliminate or control that hazard
- Other-than-serious
 - Should be corrected, but abatement documentation not required
- Regulatory
- Other findings and recommendations

Closing Conference

- Review findings
- Due dates
- Methods of abatement
- Interim protection



After the Virtual Visit

- Written report
 - Recommendations on correcting and improving safety and health program
- Findings are explained
- When applicable, corrective action procedures



After the Virtual Visit

- Follow-up visits available
- Other assistance available
- OSHA requires hazard abatement of all serious hazards
- If a serious hazard is not corrected and attempts made to find a resolution are not made, a referral to federal OSHA for potential enforcement action is possible
- Getting struck by lightning is easier than the previous bullet



How have we helped other companies?

- Suggest general approaches or options for solving a safety or health concern
- Identify kinds of help available, if needed
- Help recognize hazards in the workplace
- Provide a written report summarizing findings



Safety and Health Management Program Advice

- Consider these elements and time-tested hints and ways to enhance your existing program
 - Hazard anticipation and detection
 - Hazard prevention and control
 - Planning and evaluation
 - Administration and supervision
 - Safety and health training
 - Management leadership
 - Employee participation

OSHA On-Site Consultation Program is confidential

- Federal OSHA <u>does not know</u> which companies have used On-Site Consultation Program services
- Can a company be or remain "under the radar?"



In Review: *What is an OSHA On-Site Virtual Consultation?*

- Virtual walk-through
- Opening and closing conference
- Shortly afterward, a written report that summarizes the results of the visit will be forwarded
- The process is similar to a federal OSHA inspection
- No cost and confidential

On-Site Consultation



OSHA's On-Site Consultation Program offers no-cost and confidential occupational safety and health services to small- and medium-sized businesses in all 50 states, the District of Columbia, and several U.S. territories, with priority given to high-hazard worksites. On-Site Consultation services are separate from enforcement and do not result in penalties or citations. Consultants from state agencies or universities work with employers to identify workplace hazards, provide advice for compliance with OSHA standards, and assist in establishing and improving safety and health programs.

OSHA On-Site Program Overview

On-site consultants work with small, high-hazard employers to address the employer's overall safety and health management system and to assist them in ensuring a safe and healthful workplace for their employees.

- 88% federally funded
- 12% state funded Ohio Bureau of Worker's Compensation

Federal OSHA – Compliance Assistance Update

- Federal OSHA Compliance Assistance partner with OSHA on-site consultation
- Provide updates on OSHA policy, regulations and OSHA campaigns/initiatives


