Meeting Minutes of the State of Ohio Board of Embalmers and Funeral Directors

Board Meeting

Thursday, March 16, 2023, 10:30 a.m.

Pursuant to Ohio Rev. Code § 4717.03(A), the State of Ohio Board of Embalmers and Funeral Directors convened in room 1960 of the Vern Riffe Center for Government and the Arts at 77 South High Street, Columbus, Ohio 43215 for its regular meeting to discuss the Board's business.

Attorney General Update

Vice President Taneff recognized and introduced Senior Assistant Attorney General Elizabeth Fligner as the Board's Counselor. Mr. Taneff asked AG Fligner if she had any updates to provide the Board. Ms. Fligner reported on a recent virtual meeting between C. Patrick Denier, assistant section chief of executive agencies at the Office of Ohio Attorney General Dave Yost, Cheryl Grossman, executive director of the board, Jarrod Williams, staff member of the board office, and herself regarding Ohio Rev. Code § 4717.04.

Ms. Fligner stated that Mr. Denier led discussion about his research into the addition of section D to R.C. 4717.04 because of the passage of Ohio Senate Bill 224. Mr. Denier explained the amendment granted the executive director of the board with unusual power to cause for prosecution of an offender in a county where an alleged infraction occurred. Mr. Denier explained this ability could be perceived as overstepping local law enforcement authority and suggested amending this section of code. Mr. Denier shared examples of proposed amendment language.

There was discussion between board members and board counsel about Mr. Denier's research and proposal.

Public Comment

Vice President Taneff informed that the Board provides an opportunity for public comment during its meetings. Mr. Taneff announced that no requests were submitted prior to the meeting and asked if any guest in attendance desired the opportunity. There was none.

Upcoming Dates

Vice President Taneff read aloud the list of dates with information associated to each.

Jon Rettig moved for the Board to enter executive session per Section 121.22(G)(1) of the Ohio Revised Code to consider the discipline of a public employee. Amanda Crates seconded the motion. Vice President Taneff asked for comments or discussion on the motion. There was none.

Jon Rettig moved for the Board to adjourn its meeting. Amanda Crates seconded the motion.

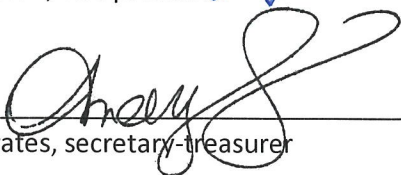

Executive Director's Report

March 2023

The renewals for facility licenses are nearly complete. Approximately 5 percent of individual license renewals have not been completed. We will be following up on those individuals.

The Green Forms for the ARPPS program are being returned. Currently, approximately 20 percent have been received.

I have completed preparation of the Budget testimony, which is scheduled for Wednesday, March 8, 2023 before the House Finance Subcommittee on Agriculture, Development and Natural Resources.

I met with Sub-Committee Chair Jones to explain the four amendments we are seeking. As I have previously shared, they include re-institution of the Crematory Operators Permit, correction of language from a 2017 statute regarding prohibition against removing dental gold, body parts, organs, or other items of value from a body prior to or after cremation without proper authorization. This was a drafting error at the time the legislation was approved.

We are also requesting funding for a staff person to oversee the ARPPS program from the fund. This was originally written into the bill but was not properly stated to be able to fund this position from the fund. Lastly, providing funding for the Indigent Burial Fund from the fund for a staff person to administer the program. When this was directed to our Board to administer the Indigent Burial and Cremation Support Program, there was no funding to provide a staff person.

There are no new fees required for any of the amendments that have been requested. Both would be an earmark of existing appropriations.

We continue to work with the Department of Health on requested improvements to the EDRS system as they evaluate a new system.

Proposed rule changes will be submitted to JCARR soon.

Five counties remain that have met their \$11,000 maximum through our Indigent Burial and Cremation Support Program. They are Butler, Lucas, Montgomery, Richland, and Summit Counties. We have 84 counties who are actively submitting applications and have added two more counties that are corresponding for more information on the program and how they may utilize it.

Amanda Crates and I presented at the OFDA Masters Training that was held on February 23, 2023. We received strong feedback from the participants. We have previously asked OFDA to have participants complete a survey indicating how many plan to serve as a Master. Out of 43 attendees, 25 indicated they plan to become a Master while 18 indicated they were seeking continuing education only.

I attended the Conference Annual Meeting March 1, 2 and 3. Jon Rettig was elected as President of The Conference. I found the time in the meetings very helpful as we discussed common challenges each of us are facing as well as best practices and how they may be utilized to assist others. I have responded to requests from other states to provide examples of our legislation to them.

Kim Grossman will be travelling to CCMS on March 9, 2023, to meet with apprentices to demonstrate the application process as well as answer any questions. This has been a good practice in the past and assists the apprentices in providing positive guidance on the process.

The quarterly newsletter, Respect, will be sent by March 30, 2023.

We continue to work with two different county prosecutors on issues dealing with pre-needs. We have been pleased with their response on the concerns we have shared.

We continue to work with DAS on the migration of the new website to align with their new guidance on consistency of state websites.

I am working with the Michigan Funeral Board because of the formal complaint we sent to them.

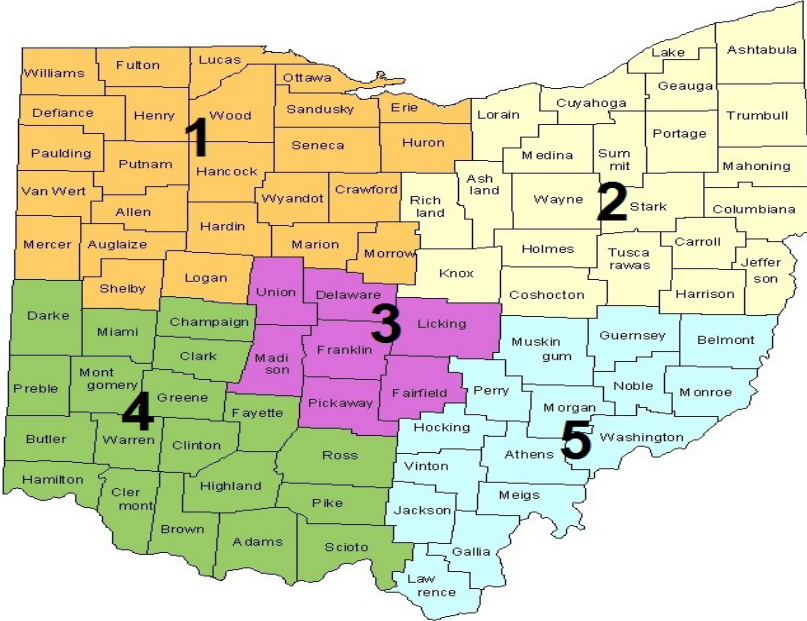
