¹⁰Figures for SMB-Analytics program are based on program-based fees. Students enrolled in this program attend full-time two semesters and 7.5 credit hours in the third semester. For students taking all distance courses, all on-site fees are waived, and the non-resident tuition is reduced to \$200.

¹¹This online certificate program is a total of 4.5 credit hours with a rate of \$945 per credit hour.
