SUBSTANCE USE PREVENTION AND RECOVERY (SUPR) PROGRAM

- Combines:
 - Drug-Free Safety Program (DFSP)
 - Substance Use Recovery and Workplace Safety Program (SUR)
 - Drug-Free Safety Grants



SUBSTANCE USE PREVENTION AND RECOVERY (SUPR) PROGRAM

Basic Level – 4% rebate

- Written substance use policy/employee education/supervisor training/drug and alcohol testing

Advanced Level – 7% rebate

- Same as the basic with enhanced drug testing (15% random of workforce)/non-termination for first positive test

Comparable – no rebate

- Allows employers with comparable program to bid on public contracts.



SUBSTANCE USE PREVENTION AND RECOVERY (SUPR) PROGRAM

Reimbursements only –

- Broader reimbursement levels
 - Policy development/revision
 - Employee education/supervisor training
 - Drug testing

Replaces DFSP Grants



SUBSTANCE USE PREVENTION AND RECOVERY (SUPR) PROGRAM

- Integrated enrollment processes for DFSP and SUR into one application
- Simplified reimbursement grant requests to the online portal
- Development of an online employee and supervisor training option through BWC's Learning Management System



SUBSTANCE USE PREVENTION AND RECOVERY (SUPR) PROGRAM

- Most program participants will automatically be eligible to apply for reimbursement grants
- Additional reimbursable expenses to include substance use assessments for employers with “second chance” policies



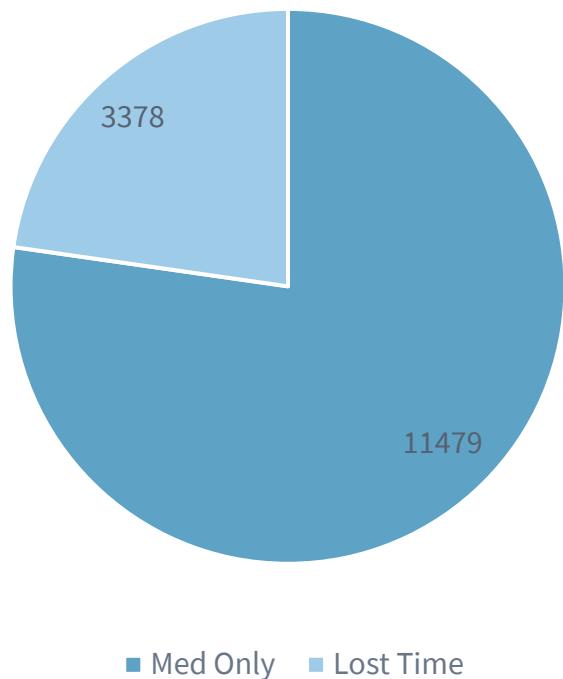
SUBSTANCE USE PREVENTION AND RECOVERY (SUPR) PROGRAM

- Safety Management Self-Assessment (SH-26) has been eliminated
- Safety Action Plan (DFSP-5) has been eliminated
- Accident Report (DFSP-1) will be required for lost-time claims only

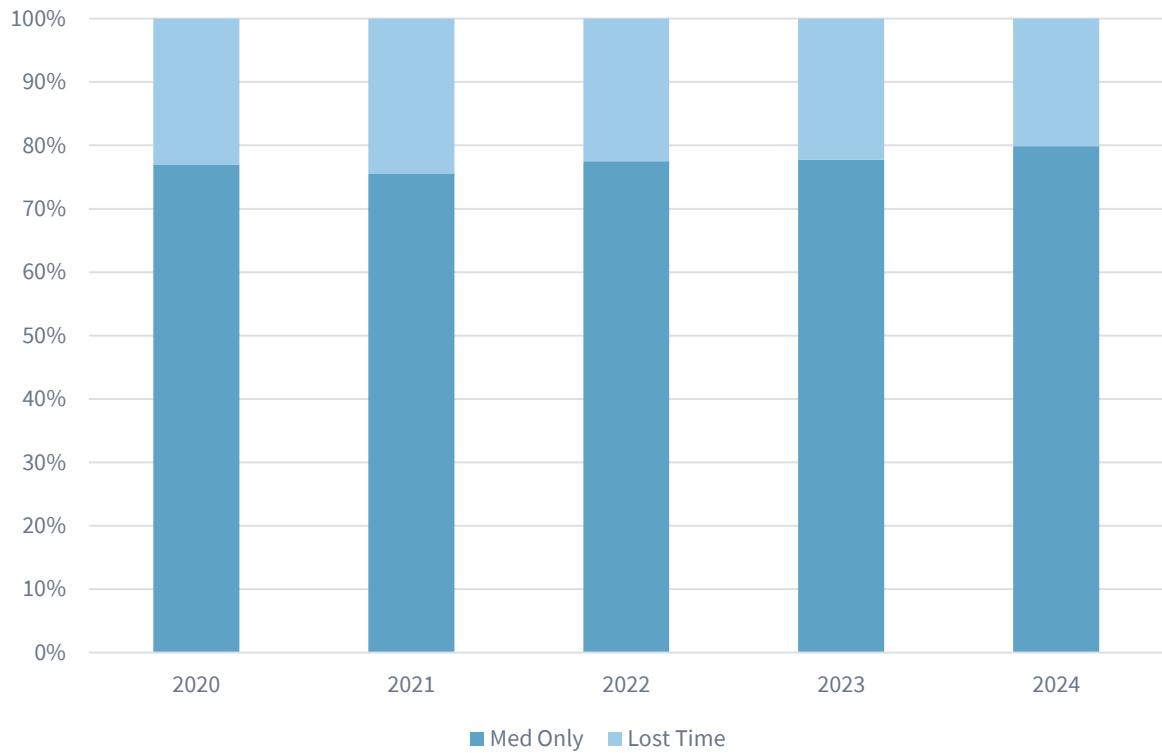


HOW MUCH LESS PAPERWORK? DFSP-1 ACCIDENT REPORT

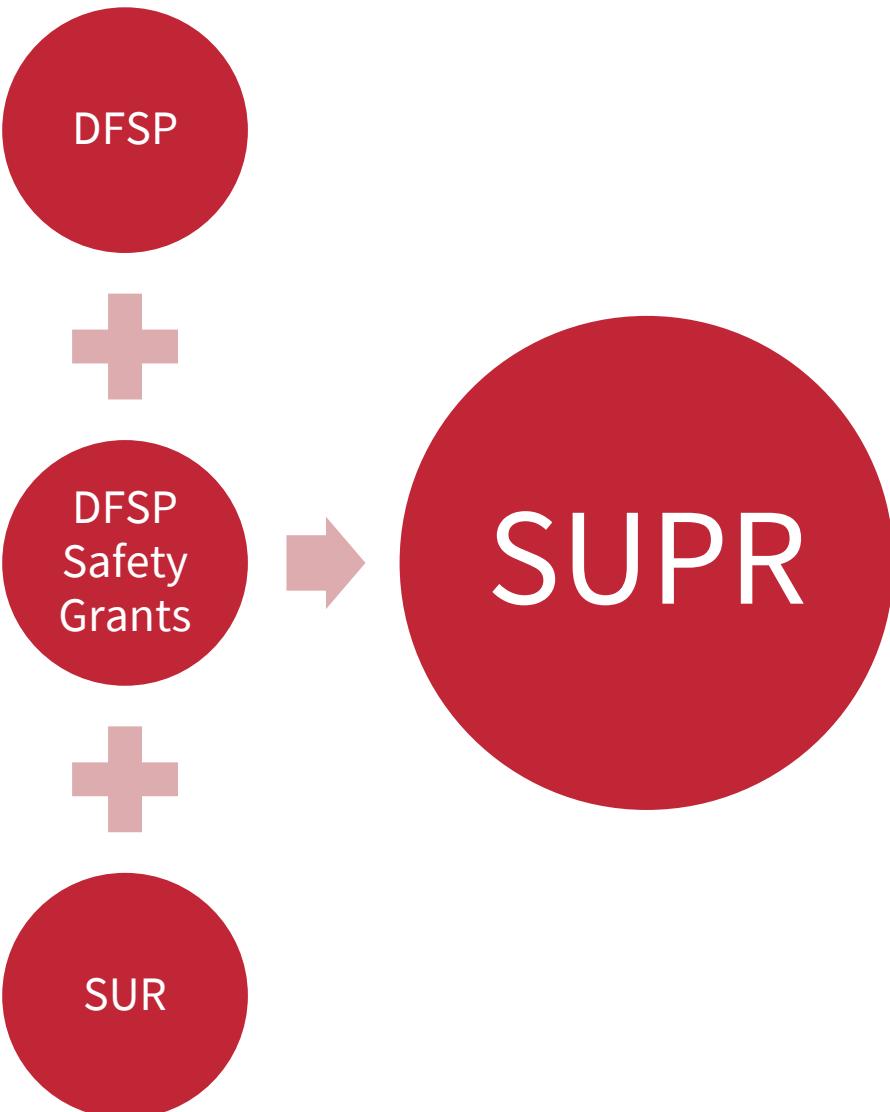
Total DFSP-1s Filed 2020 - 2024

SUBSTANCE USE PREVENTION AND RECOVERY (SUPR) PROGRAM

Enrolling in the program

Complete the [Application for Drug-Free Safety Program \(U-140\)](#) by the appropriate deadline.

On the U-140, check the program level you are requesting:

1. Advanced
2. Basic
3. Comparable
4. New option is Reimbursement only.



ADDITIONAL INFORMATION

- Private Employers effective 7/1/2025
 - The DFSP-1 is only going to be required for loss time claims
 - The DFSP-5 is eliminated
 - The SH-26 is not required under the new rules
 - DFSP Enrollment will be year-round with ability to earn pro rata premium bonus
 - You can enroll anytime but the annual report is still due March 31
- Public Employers
 - Continue to use the same annual report
 - Same rules
 - Above changes effective 1/1/2026

Re: 2025 Policy Year Renewal, Notice of Estimated Annual Premium and Workers' Compensation Certificate

Dear Employer,

 This letter includes your Notice of Estimated Annual Premium, and Premium Installment Schedule for the renewal of your workers' compensation policy that begins July 1, 2025. **This document is not a bill but an estimate to assist you in budgeting.**

 You will receive your first invoice for the 2025 policy year in June. Your first installment is due by June 23, 2025. However, you have the **option to receive a 2% discount by paying the full 12-month estimated annual premium on or before July 1, 2025**. You cannot deduct the discount up front. You can find details about our early payment discount on page two of this letter.

 Your estimated premium is based on either your completed true-up or any recent payroll changes. Please review the payroll to ensure it is in line with your estimates for the upcoming policy year. **Please note that the estimated premium is based on the information as of the letter date. Additional changes to payroll estimates may change the premium owed.** Notify us if you have changes in your operations or if you believe the payroll estimate is incorrect.

 If you need a change in your installment schedule, you must contact us by May 15, 2025. Timely payment of premium installments by the due date will prevent penalties and a lapse in coverage. You will also avoid the costs of any claims that occur during the lapse period.

If you no longer need your workers' compensation coverage, please contact us to cancel your policy. If we do not receive your request to cancel before July 1, 2025, you may be responsible for premium for the renewal period.

2% early payment discount: If you pay all installments for the policy year in full on or before July 1, 2025, we will credit your account for the 2% discount. The discount cannot reduce the total amount due below the required minimum premium of \$120. You cannot deduct the discount up front. To elect this payment option, log onto bwc.ohio.gov, and from the navigation menu, select **Make a payment** under **Employer**. You may also call us at 1-800-644-6292.

Policy cancellation: If you cancel your policy, you must notify us in writing, which may be done online. When cancelling your coverage, you must file a final payroll true-up report. To cancel your policy online, log on to bwc.ohio.gov, and from the navigation menu, select **For Employers, View My Policy**, and then **Request to Cancel**.

Important note: Once you cancel the policy, you may be eligible for a refund. We cannot modify the name on the refund. Prior to closing your business bank account, we recommend that you confirm with us that no additional refunds are in order.

Workplace injuries: Remember to contact your **managed care organization (MCO)**, **Minute Men OhioComp**, if one of your employees has a workplace injury.

True-up due date: Effective for policy year July 1, 2024 to July 1, 2025 the due date is Aug. 31st. There is no grace period.

Ohio Bureau of Workers' Compensation

Required Posting

Section 4123.54 of the Ohio Revised Code requires notice of rebuttable presumption. Rebuttable presumption means an employee may dispute or prove untrue the presumption (or belief) that alcohol, marihuana or a controlled substance not prescribed by the employee's physician is the proximate cause (main reason) of the work-related injury.

The burden of proof is on the employee to prove the presence of alcohol, marihuana or a controlled substance was not the proximate cause of the work-related injury. An employee who tests positive or refuses to submit to chemical testing may be disqualified for compensation and benefits under the Workers' Compensation Act.

 **Bureau of Workers' Compensation**
You must post this language with the Certificate of Ohio Workers' Compensation.
