## Health Insuring Corporations (HIC) Deposits & Filing Fee Schedule

Any Entity that assumes risk in a capitated arrangement or other risk-bearing mechanism will probably fall within the definition of health insuring corporation (ORC 1751.02 – 1751.05)

Non-Provider Sponsored Organization is a corporation that is not owned or controlled by a hospital or provider.

Provider Sponsored Organization is defined in 1751.01 (X) to mean a corporation that is at least 80% owned or controlled by one or more hospitals or physicians. They must provide basic health care services in all of their health care plans and substantially all of the owners must be participating providers.

For a Certificate of Authority the Ohio Department of Health (ODH) has 90 days to review filing. After ODH provides certification the Ohio Department of Insurance (ODI) has an additional 45 days for review.
