

STATE OF OHIO TITLE IV-E REIMBURSEMENT CEILING PER DIEMS FOR EFFECTIVE PERIOD APRIL 1, 2022, THROUGH MARCH 31, 2023

The JFS 02911 Title IV-E Single Cost Report for state fiscal year 2021 covers the reporting period of July 1, 2020, to June 30, 2021. The JFS 02911 Title IV-E Single Cost Report, along with the documents required by O.A.C. 5101.2-47-26.2, must be completed and filed by December 31, 2021.

For good cause and upon written application ODFJFS may grant an extension of the December 31, 2021, filing deadline in accordance with O.A.C. 5101.2-47-26.1. Approved filing deadline extensions are reflected below.

Based on this reporting period approved Title IV-E reimbursement ceiling per diems will be effective for the period April 1, 2022, through March 31, 2023. An inflation factor of 9.6% has been added to the costs associated with this reporting period.
