

STATE OF OHIO TITLE IV-E REIMBURSEMENT CEILING PER DIEMS FOR EFFECTIVE PERIOD APRIL 1, 2023, THROUGH MARCH 31, 2024

The JFS 02911 Title IV-E Single Cost Report for state fiscal year 2022 covers the reporting period of July 1, 2021, to June 30, 2022. The JFS 02911 Title IV-E Single Cost Report, along with the documents required by O.A.C. 5101:2-47-26.2, must be completed and filed by December 31, 2022.

For good cause and upon written application ODJFS may grant an extension of the December 31, 2022, filing deadline in accordance with O.A.C. 5101:2-47-26.1. Approved filing deadline extensions are reflected below.

This reporting period establishes Title IV-E reimbursement ceiling per diems for the effective period April 1, 2023, through March 31, 2024. Based on Consumer Price Index data for the reporting period, an inflation factor of 16.4% has been added to the costs associated with this reporting period.

The agencies listed below are expected to file a JFS 02911 Single Cost Report for reimbursement ceiling per diems calculation. For those agencies which have completed the cost report filing and desk review process, Title IV-E reimbursement ceiling per diems and category cost per diems are listed below and the Cost Report Status column will read "Completed." If an agency's cost report has been filed but ceiling per diems are not yet established, the Cost Report Status column will read "Received/Desk Review in Process." If an agency has not submitted a cost report, the Cost Report Status column will read "Nothing Filed Yet."

For maintenance ceiling per diems listed with an asterisk, OAC rule 5101:2-47-10 establishes a contemporaneous payment system for purchased foster care services. Under this system, your Title IV-E maintenance reimbursement ceiling per diem (e.g., the amount paid to the foster parent) is set at the statewide maximum ceiling as currently established through procedure letter in the Family, Children and Adult Services Manual (Procedure Letter No. 398 renews the statewide maximum of \$200/day). For those agencies which have completed the cost report filing and desk review process, Title IV-E reimbursement ceiling per diems and category cost per diems are listed below and the Cost Report Status column will read "Completed." If an agency's cost report has been filed but ceiling per diems are not yet established, the Cost Report Status column will read "Received/Desk Review in Process." If an agency has not submitted a cost report, the Cost Report Status column will read "Nothing Filed Yet."

For maintenance ceiling per diems listed with an asterisk, O.A.C rule 5101:2-47-10 establishes a contemporaneous payment system for purchased foster care services. Under this system, your Title IV-E maintenance reimbursement ceiling per diem (e.g., the amount paid to the foster parent) is set at the statewide maximum ceiling as currently established through procedure letter in the Family, Children and Adult Services Manual (Procedure Letter No. 398 renews the statewide maximum of \$200/day).
