To Whom It May Concern:


In November 2023, the Company previously provided notice that there would be separations at Nestlé USA's Solon campus which includes 30003 Bainbridge Rd, Solon, OH 44139, 5750 Harper Road, Solon, OH 44139 and 30000 Bainbridge Road, Solon, OH 44139 in December 2023 that potentially impacted the federal WARN Act. These were partial layoffs at the site, without bumping rights for affected employees. The schedule of layoffs for this prior project commenced

on December 31, 2023 and are expected to continue through December 31, 2024. We have previously provided the job titles and number of impacted employees associated with these layoffs.

This notice is to advise you that the Company will have additional layoffs at the Solon site unconnected to this prior project. Some of the layoffs will not independently trigger WARN notice requirements. However, in an abundance of caution, the Company is providing notice of all planned separations and the schedule for such separations through December 31, 2024, in the enclosed Attachment A which lists all impacted job titles and number of impacted employees. All layoffs at the site are anticipated to be permanent, and there are no bumping rights.
