RE: WARN Act Notice

Dear Ms. Handberg:

Pursuant to the Worker Adjustment and Retraining Notification Act (the "WARN Act"), this letter will serve as official notice that, due to the closing of its warehouse operations at its Columbus Customer Fulfillment Center (the "CFC"), Sid Tool Co., Inc. dba MSC Industrial Direct Co., Inc. (the "Company") will be permanently laying off approximately 130 of its employees at its facility located at 1568 Georgesville Rd. in Columbus, Ohio. The anticipated layoff date for most employees is June 14, 2024, but terminations could occur as early as May 14, 2024, and some terminations could occur after June 14, 2024, on a rolling basis.

The employees at the Company's Columbus, Ohio facility are not represented by any union. No employee will have bumping rights.

Employees may qualify for unemployment benefits. No later than three (3) working days prior to each laid-off employee's separation from the Company, you will be provided with a supplemental notice. This notice will include each laid-off employee's start date, end date, and last gross wage to help assess eligibility for unemployment benefits.
