RE: Notice of Workforce Reduction

To Whom It May Concern:

On January 10, 2025, Air Wisconsin Airlines LLC (the "Company") announced publicly a strategic shift in its operations following the termination of its capacity purchase agreement with American Airlines, Inc. effective April 3, 2025.

Since that announcement, the Company has been working to develop alternative flying opportunities, which it expects to announce in the coming weeks. It is likely that the Company's strategy will involve some level of company-wide workforce reductions, although at this point, the Company is unable to assess the extent of those reductions. Any reduction may begin as soon as March 31, 2025, or during the 14-day period thereafter, and affect the Company's business located at:

Dayton International Airport 3600 Terminal Dr. Dayton, OH 45377

At this time, the reductions are expected to be temporary for our unionized employees and permanent for management/salaried employees. The duration of the reduction is unknown and will be dependent on alternative flying opportunities. It may result in the layoff of approximately 201 employees- 20 management/salaried employees and 185 union/represented employees in the state of Ohio. Attached is the list of job titles for the positions that will be affected and the number of employees in each position.

Of the 185 affected employees that are represented, the contact information for the different unions is as follows:

Due to language included in the applicable collective bargaining agreements, including "bumping rights", it is impossible to predict which of the represented employees will ultimately be affected.

Each employee who may be affected by any reduction in workforce has been notified and provided with the regulatory required information. The Company will ensure that any affected employees will be paid all earned wages and agreed upon benefits at the time of separation due to any such reduction.
