This letter is to inform you that Ohio Eagle Distributing, LLC (the "Company") has entered into an agreement to sell all of its assets. If the transaction closes, it will result in the termination of all of the Company's employees at the following facilities on or about September 8, 2025:

West Chester, OH 45069

3535 Saint Johns Road
Lima, OH 45804

All separations will be permanent; future employment opportunities, if any, will be communicated by the buyer. While notice under The Workers Adjustment and Retraining Notification Act ("WARN") may not be required, in an abundance of caution, the Company is providing notice.


Some of the employees at the West Chester facility are represented by Teamster Local Union 1199. The name and chief elected officer of that union is:

Some of the employees at the Lima facility are represented by the International Brotherhood of Teamsters Local Union No. 908. The name and chief elected officer of that union is:

There are currently 124 individuals employed at the Company's West Chester facility and 54 individuals employed at the Company's Lima facility. All employees will be impacted. Because the Company will be permanently ceasing its operations, any bumping rights provided by the collective bargaining agreements are not applicable. Employees who are not represented by a union do not have any bumping rights.
