Re: Announcement of Planned Action

Dear Administrator Tarr:

We are writing to give you notice that Premier Healthcare Solutions, Inc. ("Premier") will be winding down its Contigo Health line of business ("Contigo"). Accordingly, there will be a total closure of the Contigo Hudson, Ohio facility, located at 300 Executive Pkwy W, Ste 100, Hudson, OH, on December 31, 2025. The entire facility will be closed and all employees at the facility will be impacted. This closure is expected to be permanent. The expected date of the first separation will be December 31, 2025. The reason for the closure is the entire Contigo business is winding down.

All affected employees have been notified of their separation dates and that their separation from employment will be permanent. Attached is a list of the job positions and number of individuals who will be affected by the closure along with the anticipated schedule for job losses. There will not be any bumping rights for the affected employees, that is, employees will not be able to displace more junior



employees out of their job positions as a result of this closure. There is no union representing affected employees. There was no action that could be taken to avoid this shutdown as the business is winding down.

Impacted employees will be eligible for the following outplacement services: : career coaching, interviewing advice and practice, negotiation skills training, professional branding, resume development, and the provision of job search resources. Impacted employees can apply for unemployment online at https://unemployment.cmt.ohio.gov/cmtview/. Impacted employees may also apply by phone by calling 877-644-6562. Call center hours are Monday through Friday 8 a.m. to 5 p.m.
