Re: WARN NOTICE - CLOSING OF MIDDLEFIELD DISTRIBUTION CENTER

Dear Ms. Handberg:

This Notice is being provided to inform you that Tarkett USA Inc. (the Company) will be closing its Middlefield, Ohio distribution center located at 16077 Industrial Parkway, Middlefield, Ohio, and laying off 92 employees at the facility, beginning on February 28, 2025. The closing is expected to be permanent. Given the facility is closing, bumping rights do not exist.

Attached to this Notice are the job titles of the positions to be affected and the number of affected employees in each job classification.
