Re: Revised WARN Notice with Change of Employment Termination Date for Twenty-Seven Employees

Administrator Tarr:

We informed you by letter dated May 29, 2025 that the Daniel Drake Center for Post-Acute Care located at 151 West Galbraith Road, Cincinnati, Ohio 45216 was expected to close on September 30, 2025. We told you the entire Daniel Drake Center for Post-Acute Care facility was expected to close. We told you the closure was expected to be permanent. Because this is a facility-wide permanent closure, there would be no bumping rights for impacted employees. We told you that approximately 474 employees were expected to have their employment terminated with this closure. None of the impacted employees are represented by a Union.

All of the aforementioned information continues to be true. We also told you in the May 29, 2025 letter that the expected date by which all the employees were expected to have their employment terminated was October 3, 2025. This continues to be the case for the vast majority of the employees. However, Drake has a need to continue to employ 27 employees whose positions are listed below to service the adjacent Bridgeway Pointe facility as we continue to run that facility with an effort to sell it. We cannot at this time identify a specific date for the effective date of the transfer of Bridgeway Pointe but it appears the date will be during the first half of calendar year 2026. We will provide you with an updated notice at least 60 days prior to the termination of these employees employment.

I write to inform you that the Daniel Drake Center for Post-Acute Care located at 151 West Galbraith Road, Cincinnati, Ohio 45216 is expected to close on September 30, 2025. The entire facility will be closed. We expect to continue to employ the employees for a few days after the September 30, 2025 closure to assist in the shutdown process. The employment of all employees is expected to terminate on October 3, 2025. This closure is expected to be permanent. Because this is facility-wide permanent closure, there are no bumping rights for any affected employees. Approximately 474 employees are expected to have their employment terminated with this closure. None of the impacted employees are represented by a union.
