We are writing to give you notice that there will be a plant closing and associated layoffs at Belmont County Coal Resources, Inc.'s Century Mine located at 43521 Mayhugh Hill Road, Beallsville, Ohio. The layoff will occur on June 15, 2022 or within the next two (2) weeks. This layoff will be permanent.

All affected employees have been notified that their layoff from employment will be permanent. The layoff will occur on June 15, 2022, or within the following two (2) weeks and will involve approximately one-hundred six (106) positions.


