Re: Notice of Layoffs

To Whom It May Concern,

Monitronics International, Inc., d/b/a Brinks Home ("Brinks Home") (EIN 74-2719343) is reducing its workforce by eliminating field service offices in certain locations. These actions are expected to result in the permanent elimination of 81 employees—14 of which are salaried employees and 67 of which are hourly employees. Six (6) of these employees reside in the State of Ohio.

This layoff is expected to be permanent. All of these positions will be eliminated as of March 5, 2023. Enclosed herewith is a list of job titles and the number of employees effected within each job title. Brinks Home will ensure that these employees will be paid all earned wages and agreed upon benefits.

To the extent that this reduction constitutes a covered event under the Worker Adjustment and Retraining Notification (WARN) Act or any similar state statute, this letter is intended to fulfill any requirements imposed under these provisions. By providing this information, however, Brinks Home does not concede that any such provision applies or that notice is required.
