### NOTICE OF PUBLIC HEARING AND RULES REVIEW

Pursuant to Ohio Revised Code Section 4301.06, the Ohio Liquor Control Commission is required to hold no fewer than four public hearings each year to hear general comments, complaints, and suggestions as to its policies, adopted pursuant to Chapters 4301 and 4303 of the Ohio Revised Code, to consider other business and procedures of the Commission, and for the dissemination of information to the public.

In compliance with this provision, the Ohio Liquor Control Commission will hold a public hearing on **Thursday, December 7, 2023, at 9:00 a.m.** The public hearing will be held at the Riffe Center, 77 South High Street, 19<sup>th</sup> Floor, Columbus, Ohio 43215.

Additionally, the Commission will receive any comments or testimony concerning its administrative review of its rules under the Ohio Administrative Code, and particularly the following administrative rules, all of which are subject to five-year review in 2024 pursuant to Section 119.03(C) of the Ohio Revised Code:

OAC 4301:1-1-16	Closing authority.
OAC 4301:1-1-17	Sanitation requirements.
OAC 4301:1-1-68	Sales reports of B-1 permit holders.
OAC 4301:1-1-72	Minimum markup on beer.
OAC 4301:1-1-73	Differential pricing practices: manner and frequency of price changes for beer.
OAC 4301:1-2-01	Definitions.
OAC 4301:1-2-02	Procedures for accessing confidential personal information.
OAC 4301:1-2-03	Valid reasons for accessing confidential personal information.
OAC 4301:1-2-04	Confidentiality statutes.
OAC 4301:1-2-05	Restricting and logging access to confidential personal information in computerized personal information systems.
