NOTICE OF PUBLIC HEARING AND RULES REVIEW

Pursuant to Ohio Revised Code Section 4301.06, the Ohio Liquor Control Commission is required to hold no fewer than four public hearings each year to hear general comments, complaints, and suggestions as to its policies, adopted pursuant to Chapters 4301 and 4303 of the Ohio Revised Code, to consider other business and procedures of the Commission, and for the dissemination of information to the public.

In compliance with this provision, the Ohio Liquor Control Commission will hold a public hearing on **Thursday, September 14, 2023, at 9:00 a.m.** The public hearing will be held at the Riffe Center, 77 South High Street, 19th Floor, Columbus, Ohio 43215.

Additionally, the Commission will receive any comments or testimony concerning its administrative review of its rules under the Ohio Administrative Code, and particularly the following administrative rules, all of which are subject to five-year review in 2023 pursuant to Section 119.03(C) of the Ohio Revised Code:

OAC 4301:1-1-01	Title and validity.
OAC 4301:1-1-03	Wine requirements.
OAC 4301:1-1-22	Consent for importing alcoholic beverages for resale in Ohio.
OAC 4301:1-1-24	Miscellaneous beer, wine and mixed beverage requirements.
OAC 4301:1-1-33	Consumer tasting activities and sampling at retail permit premises.
OAC 4301:1-1-43	Furnishing signs, fixtures, equipment, advertising specialties, return of merchandise: limitations thereon: prohibited practices and prohibition of cash deposit or prepayment.
OAC 4301:1-1-62	Inspection of permit premises – hindering or assaulting forbidden.
OAC 4301:1-1-71	Sponsorship of athletic events or tournaments, concerts, shows, or entertainment.

The Commission also seeks public comment or testimony regarding the following administrative rules:

OAC 4301:1-1-49	Hours of sale of alcoholic beverages.
OAC 4301:1-1-56	Employment of underage persons.
