SUBJECT: Managed Care Entity Explanation of Benefits Suppression

---

In accordance with 42 CFR 455.20, Managed Care Organizations (MCOs), MyCare Ohio Plans (MCOPs), the OhioRISE plan, and the Single Pharmacy Benefit Manager (SPBM), henceforth referred to as Managed Care Entities (MCEs), are required to implement a method for verifying with members that services billed by providers were indeed received. The Ohio Department of Medicaid (ODM) acknowledges that MCEs may manage Explanation of Benefits (EOBs) in various ways. This guidance is being issued to ensure that, regardless of the method used for distributing EOBs, MCEs are compliant with the suppression of services as outlined in the following laws:

This guidance is applicable to mailed and online EOBs.
