Please find below a summary of actions taken or initiated by the State Medical Board of Ohio and an update of Board matters pending or decided in courts as of August 9, 2023.

**PRE-HEARING SUSPENSION**

**HARTMAN, David M., M.D., (#35.084120)** – Dover, Ohio

Pursuant to Section 4731.22(G), license to practice allopathic medicine and surgery summarily suspended based on Board's determination that there is clear and convincing evidence that doctor is in violation of Sections 4731.22(B)(6), and 4731.22(B)(20) Ohio Revised Code, and that their continued practice presents a danger of immediate and serious harm to the public. Order effective 8/9/23. (See also: Citations/Proposed Denials below.)

**MCFARLANE, Keri J., M.D., (#35.134909)** – Knoxville, Tennessee

Pursuant to Section 4731.22(G), license to practice allopathic medicine and surgery summarily suspended based on Board's determination that there is clear and convincing evidence that doctor is in violation of Sections 4731.22(B)(22), and 4731.22(B)(5) Ohio Revised Code, and that their continued practice presents a danger of immediate and serious harm to the public. Order effective 8/9/23. (See also: Citations/Proposed Denials below.)

Based on allegations with respect to the care and treatment of one specified patient, when the doctor inappropriately treated and/or failed to appropriately treat or document treatment, those actions and/or omissions individually and/or collectively constitute: violating or attempting to violate, directly or indirectly, or assisting in or abetting the violation of, or conspiring to violate, any provisions of this chapter or any rule promulgated by the board, to wit: the Board's Rules pertaining to controlled substances, which also constitutes a failure to maintain minimal standards applicable to the selection or administration of drugs; and a departure from, or failure to conform to, minimal standards of care of similar practitioners under the same or similar circumstances, whether or not actual injury to a patient is established; and the selling, prescribing, giving away, or administering for other than legal and legitimate therapeutic purposes; and the Board's Rules pertaining to the Ohio Automated Rx Reporting System. **DEAN, Nicole M., MT. App. - Cleveland, Ohio**

Based on the submission of an application to practice massage therapy, and on the massage therapist's finding of guilt in the Medina County Court of Common Pleas to one felony count of Improperly Handling Firearms in a Motor Vehicle, and on the massage therapist's admission they had advertised themselves as a licensed massage therapist and offered to provide massage therapy services while not holding a license, those actions and/or omissions individually and/or collectively constitute: a plea of guilty to, a judicial finding of guilt of, or a judicial finding of eligibility for intervention in lieu of conviction for, a felony; and making a false, fraudulent, deceptive, or misleading statement in the solicitation of or advertising for patients; in relation to the practice of medicine and surgery, osteopathic medicine and surgery, podiatric medicine and surgery, or a limited branch of medicine; or in securing or attempting to secure any license or certificate to practice issued by the board; and violating or attempting to violate, directly or indirectly, or assisting in or abetting the violation of, or conspiring to violate, any provisions of this chapter or any rule promulgated by the board, to wit: Scope of Practice, and Practicing Medicine without a License or Certificate. **EVERLY, Bradley P., M.D., (#35.097443) – Sylvania, Ohio**

Based on allegations with respect to the care and treatment of ten specified patients, when the doctor inappropriately treated and/or failed to appropriately treat and/or failed to appropriately document treatment, those actions and/or omissions individually and/or collectively constitute: failure to maintain minimal standards applicable to the selection or administration of drugs, or failure to employ acceptable scientific methods in the selection of drugs or other modalities for treatment of disease; and a departure from, or the failure to conform to, minimal standards of care of similar practitioners under the same or similar circumstances, whether or not actual injury to a patient is established; and violating or attempting to violate, directly or indirectly, or assisting in or abetting the violation of, or conspiring to violate, any provisions of this chapter or any rule promulgated by the board, to wit: Standards and procedures for review of the Ohio Automated RX Reporting System; and Controlled Substances - Utilization for chronic weight management; and General provisions pertaining to controlled substances. **HARTMAN, David M., M.D., (#35.084120) – Dover, Ohio**

Based on allegations with respect to the care and treatment of three specified patients, when the doctor inappropriately treated and/or failed to appropriately treat and/or failed to appropriately document treatment, those actions and/or omissions individually and/or collectively constitute: a departure from, or the failure to conform to, minimal standards of care of similar practitioners under the same or similar circumstances, whether or not actual injury to a patient is established; and violating or attempting to violate, directly or indirectly, or assisting in or abetting the violation of, or conspiring to violate, any provisions of this chapter or any rule promulgated by the board, to wit: Prohibitions regarding sexual misconduct. Notice of Summary Suspension and Opportunity for Hearing mailed 8/10/23.

**MCFARLANE, Keri J., M.D., (#35.134909) – Knoxville, Tennessee**

Based on allegations that prior disciplinary actions by: the Commonwealth of Kentucky Board of Medical Licensure, which issued a 3/24/23 Emergency Order of Suspension; the Alabama Medical Licensure Commission, which issued a 4/13/23 Administrative Suspension; the Virginia Department of Health Professions, which issued an 4/18/23 Order of Mandatory Suspension; the Arkansas State Medical Board, which issued a 4/25/23 Emergency Order of Suspension and Notice of Hearing; the Tennessee Board of Medical Examiners which issued a 4/26/23 Order of Suspension; and the submission of a 6/28/22 renewal application wherein the doctor failed to disclose a 3/4/21 Indictment issued by the United States District

Court, Eastern District of Kentucky, those actions and/or omissions individually and/or collectively constitute: any of the following actions taken by an agency responsible for authorizing, certifying, or regulating an individual to practice a health care occupation or provide health care services in this state or another jurisdiction, for any reason other than the nonpayment of fees: the limitation, revocation, or suspension of an individual's license to practice; acceptance of an individual's license surrender; denial of a license; refusal to renew or reinstate a license; imposition of probation; or issuance of an order of censure or other reprimand; and making a false, fraudulent, deceptive, or misleading statement in the solicitation of or advertising for patients; in relation to the practice of medicine and surgery, osteopathic medicine and surgery, podiatric medicine and surgery, or a limited branch of medicine; or in securing or attempting to secure any license or certificate to practice issued by the board. **MEHTA**, Monal A., M.D., (#35.065500) – Cincinnati, Ohio

Based on allegations that when the doctor signed blank prescriptions for controlled substances and left them to be filled by staff during her absence for patients with whom she had minimal contact, those actions and/or omissions individually and/or collectively constitute: commission of an act in the course of practice that constitutes a misdemeanor in this state, regardless of the jurisdiction in which the act was committed, to wit: Authority of licensed health professional; and violating or attempting to violate, directly or indirectly, or assisting in or abetting the violation of, or conspiring to violate, any provisions of this chapter or any rule promulgated by the board, to wit: General Provisions, which also constitutes a failure to maintain minimal standards applicable to the selection or administration of drugs, or failure to employ acceptable scientific methods in the selection of drugs or other modalities for treatment of disease; and a departure from, or the failure to conform to, minimal standards of care of similar practitioners under the same or similar circumstances, whether or not actual injury to a patient is established. Notice of Opportunity for Hearing mailed 8/10/23.

**OBU**, Fidelis I., M.D., (#35.131496) – Toledo, Ohio

Based on allegations that when the doctor invited a former patient and co-worker to his residence where he groped her breasts by force, pushed her onto a bed and held her there by her neck, and then attempted to pull down her pants while rubbing his erect penis against her body and making statements indicating forced sexual intercourse and then subsequently shut and locked the residence door when she tried to leave, those actions and/or omissions individually and/or collectively constitute: violating or attempting to violate, directly or indirectly, or assisting in or abetting the violation of, or conspiring to violate, any provisions of this chapter or any rule promulgated by the board, to wit: the Board's Rule pertaining to Sexual misconduct, which also constitutes a departure from, or the failure to conform to, minimal standards of care of similar practitioners under the same or similar circumstances, whether or not actual injury to a patient is established; and the commission of an act that constitutes a felony in this state, regardless of the jurisdiction in which the act was committed, to wit: Gross Sexual Imposition, Kidnapping, and Abduction. **SCHROETER**, Kenneth A., D.O., (#34.010633) – Chester, New Hampshire

Based on allegations that a prior disciplinary action by the Commonwealth of Kentucky Board of Medical Licensure which issued a 4/20/23 Agreed Order, those actions and/or omissions individually and/or collectively constitute: any of the following actions taken by an agency responsible for authorizing, certifying, or regulating an individual to practice a health care occupation or provide health care services in this state or another jurisdiction, for any reason other than the nonpayment of fees: the limitation, revocation, or suspension of an individual's license to practice; acceptance of an individual's license

surrender; denial of a license; refusal to renew or reinstate a license; imposition of probation; or issuance of an order of censure or other reprimand. Notice of Opportunity for Hearing mailed 8/10/23.

**SMITH, Scott W., M.D., (#35.144277)** – Mount Pleasant, South Carolina

Based on allegations that when the Drug Enforcement Administration issued an Order to Show Cause and Immediate Suspension of Registration which immediately suspended the doctor's registration, and when the doctor voluntarily surrendered his DEA registration, those actions and/or omissions individually and/or collectively constitute: the revocation, suspension, restriction, reduction, or termination of clinical privileges by the United States department of defense or department of veterans affairs or the termination or suspension of a certificate of registration to prescribe drugs by the drug enforcement administration of the United States department of justice. **CHALIFOUX, Roland F., Jr., D.O. App. – St. Clairsville, Ohio**

Application for license to practice osteopathic medicine and surgery granted, and immediately suspended for an indefinite period of time, and subject to conditions for reinstatement including completion of a Post-Licensure Assessment System, and probationary terms conditions and limitations for at least three years. Based on the submission of an application to practice osteopathic medicine and surgery, and on the finding that the doctor's prior disciplinary history including a 8/13/14 Notice and a 1/13/16 Order issued by the State Medical Board of Ohio, and prior actions by: the Texas Medical Board which issued a 7/19/02 Temporary Suspension Order and a 6/8/04 Revocation Order; and the Michigan Department of Community Health, Bureau of Health Professions which issued a 7/21/04 Order of Summary Suspension, a Consent Order adopted on 2/3/05, and a 10/28/05 Final Order Granting Reinstate; and the West Virginia Board of Osteopathy which issued a 9/1/04 Consent Agreement and Order; and also based on the doctor's DEA registrations being suspended and/or terminated in Texas, and West Virginia; and on the doctor's Medicaid provider agreement being suspended by the Ohio Department of Medicaid which individually and/or collectively constitute: any of the following actions taken by an agency responsible for authorizing, certifying, or regulating an individual to practice a health care occupation or provide health care services in this state or another jurisdiction, for any reason other than the nonpayment of fees: the limitation, revocation, or suspension of an individual's license to practice; acceptance of an individual's license surrender; denial of a license; refusal to renew or reinstate a license; imposition of probation; or issuance of an order of censure or other reprimand; and the revocation, suspension, restriction, reduction, or termination of clinical privileges by the United States department of defense or department of veterans affairs or the termination or suspension of a certificate of registration to prescribe drugs by the drug enforcement administration of the United States department of justice; and the termination or suspension from participation in the Medicare or Medicaid programs by the department of health and human services or other responsible agency. **KOOSHKABADI, Ali, M.D., (#35.141180) – Youngstown, Ohio**

License to practice medicine and surgery indefinitely suspended, and subject to conditions for reinstatement, and probationary terms, conditions, and limitations for at least five years. Based on the finding that when the doctor made repeated public threats of violence, terroristic threats, and caused disturbances resulting in police intervention and admission to a behavioral healthcare center for psychiatric examination, those acts and/or admissions, individually and/or collectively constitute an inability to practice according to acceptable and prevailing standards of care by reason of mental illness or physical illness, including, but not limited to, physical deterioration that adversely affects cognitive, motor, or perceptive skills. **RAVICHANDRAN**, Yagnaram, M.D., (#35.133321) – Indianapolis, Indiana

The Notice of Opportunity issued on 12/14/22 is dismissed. Order effective 8/10/23.

**SHRADER**, Gina Marie, M.T., (#33.021591) – Parma, Ohio

Application for restoration of license to practice massage therapy granted, and immediately suspended for a definite period of sixty (60) days, and subject to payment of a five hundred dollar (\$500.00) fine, and probationary terms, conditions and limitations for at least one year. Based on the massage therapist's submission of an application for restoration of her license to practice massage therapy, and on the finding that when the massage therapist continued to practice massage therapy despite her license having expired, those acts and/or omissions, individually and/or collectively, constitute: Commission of an act that constitutes a felony in this state, regardless of the jurisdiction in which the act was committed. Order effective 8/17/23. (Journal Entry-No Hearing Requested)

**TENPENNY**, Sherri J., D.O., (#34.003789) – Middleburg Heights, Ohio

License to practice osteopathic medicine and surgery is indefinitely suspended, and subject to payment of a three thousand dollar (\$3,000.00) fine, and conditions for reinstatement. Based on the finding that when the doctor failed to respond to Board investigators, interrogatories, an investigatory deposition, and an investigative office conference those acts and/or omissions, individually and/or collectively, constitute: failure to cooperate in an investigation conducted by the board including failure to comply with a subpoena or order issued by the board or failure to answer truthfully a question presented by the board in an investigative interview, an investigative office conference, at a deposition, or in written interrogatories, except that failure to cooperate with an investigation shall not constitute grounds for discipline under this section if a court of competent jurisdiction has issued an order that either quashes a subpoena or permits the individual to withhold the testimony or evidence in issue. Order effective 8/10/23.

**WASHINGTON**, Jordan A., M.T., (#33.024055) – Covington, Kentucky

License to practice massage therapy permanently revoked, and subject to payment of an eighteen thousand dollar (\$18,000.00) fine. Based on the finding that when the massage therapist touched the breasts of a patient and digitally penetrated her vagina; and inappropriately touched the breasts of another patient; and was uncooperative with a OSMB investigator; and falsely answered "no" to a question on his license renewal asking whether allegations or complaints had been filed against his license, which individually and/or collectively constitute: commission of an act that constitutes a felony in this state, regardless of the jurisdiction in which the act was committed, to wit: Sexual Battery; and violating or attempting to violate, directly or indirectly, or assisting in or abetting the violation of, or conspiring to violate, any provisions of this chapter or any rule promulgated by the board, to wit: the Board's prohibition regarding sexual misconduct; failure to cooperate in an investigation conducted by the board under division (F) of this section, including failure to comply with a subpoena or order issued by the board or failure to answer truthfully a question presented by the board in an investigative interview, an investigative office conference, at a deposition, or in written interrogatories, except that failure to cooperate with an investigation shall not constitute grounds for discipline under this section if a court of competent jurisdiction has issued an order that either quashes a subpoena or permits the individual to withhold the testimony or evidence in issue; and making a false, fraudulent, deceptive, or misleading statement in the solicitation of or advertising for patients; in relation to the practice of medicine and surgery, osteopathic medicine and surgery, podiatric medicine and surgery, or a limited branch of medicine; or in securing or attempting to secure any license or certificate to practice issued by the board. Order effective 8/10/23. (Journal Entry-No Hearing Requested)

**ZEDAKER, James, P.A., (#50.002173RX) – Tallahassee, Florida**

License to practice as a physician assistant suspended for a definite period of six months, and subject to payment of a one thousand dollar (\$1,000.00) fine, and probationary terms, conditions and limitations for at least one year. Based on the submission of an application to renew a license to practice as a physician assistant, and on the finding that when the physician assistant falsely answered “no” to two questions regarding whether the physician assistant had been subject to any investigation, despite a pending investigation at Florida State University, which individually and/or collectively, constitute: making a false, fraudulent, deceptive, or misleading statement in soliciting or advertising for employment as a physician assistant; in connection with any solicitation or advertisement for patients; in relation to the practice of medicine as it pertains to physician assistants; or in securing or attempting to secure a license to practice as a physician assistant. Order effective 8/10/23.

**ATANASOFF, Nicholas A., D.O., (#34.007837) – Cleveland, Ohio**

License to practice osteopathic medicine and surgery reinstated, and subject to probationary terms, conditions and limitations for at least five years. Based on the doctor having completed all the requirements for reinstatement of license pursuant to the terms of the 02/08/2023 Consent Agreement. Agreement effective 8/9/23.

**BYERLY, Paul, D.O., (#34.015030) – Louisville, Ohio**

License to practice osteopathic medicine and surgery reprimanded, and subject to payment of a seven thousand five hundred dollar (\$7,500.00) fine. Based on the doctor’s admission that when he documented in patient charts of performing history and physical examinations that he did not physically see or examine, those acts and/or omissions individually and/or collectively constitute: Making a false, fraudulent, deceptive, or misleading statement in the solicitation of or advertising for patients; in relation to the practice of medicine and surgery, osteopathic medicine and surgery, podiatric medicine and surgery, or a limited branch of medicine; or in securing or attempting to secure any license or certificate to practice issued by the board. Agreement effective 8/9/23.

**FREEMAN, Mahogney, M.T., Applicant – Canton, Ohio**

Application to practice massage therapy granted, and immediately suspended for an indefinite period of time, and subject to general probationary requirements, and conditions for reinstatement. Based on the submission of an application to practice massage therapy, and on the massage therapist’s admission that her plea of guilty and conviction to one felony count of Unlawful Possession of Dangerous Ordinance, and her plea of guilty and conviction to one felony count Aggravated Possession of Drugs in the Hamilton County Common Pleas Court, Hamilton County Ohio, and on her admission that her failure to submit to a chemical dependency examination as ordered by the Board was not due to circumstances beyond her control, those acts and/or omissions individually and/or collectively constitute: a plea of guilty to, a judicial finding of guilt of, or a judicial finding of eligibility for intervention in lieu of conviction for, a felony; and that she is unable to practice according to acceptable and prevailing standards of care by reason of her habitual or excessive use or abuse of drugs, alcohol, or other substances that impair ability to practice. Agreement effective 8/9/23.

**LUSK, Timothy A., L.M.T., (#33.021412) – Saint Paris, Ohio**

License to practice massage therapy suspended for an indefinite period of time but not less than one hundred fifty (150) days, and subject to payment of a three thousand five hundred dollar (\$3,500.00) fine, general probationary requirements and conditions for reinstatement including entering into a subsequent consent agreement. Based on the massage therapist's admission that when the massage therapist sent text messages and private messages to two current patients asking them out for a date, those acts and/or omissions, individually and/or collectively constitute: violating or attempting to violate, directly or indirectly, or assisting in or abetting the violation of, or conspiring to violate, any provisions of this chapter or any rule promulgated by the board, to wit: the Board's prohibition regarding engaging in sexual misconduct with a patient, which also constitutes a departure from, or the failure to conform to, minimal standards of care of similar practitioners under the same or similar circumstances, whether or not actual injury to a patient is established. Agreement effective 8/9/23.

**SILVA, John, D.O., (#34.013940) – Lancaster, Ohio**

License to practice osteopathic medicine and surgery reprimanded, and subject to payment of a three thousand dollar (\$3,000.00) fine, and probationary terms and conditions until completion of educational courses. Based on the doctor's admission that when he demonstrated unprofessional communication during interactions with a co-worker in the workplace setting, those acts and/or omissions, individually and/or collectively constitute: violation of any provision of a code of ethics of the American medical association, the American osteopathic association, the American podiatric medical association, or any other national professional organizations that the board specifies by rule, to wit: Section 16 of the American Osteopathic Association Code of Ethics pertaining to sexual harassment. Agreement effective 8/9/23.

**WASKY, Raymond P., R.C.P. (#RCP.8751), - Kettering, Ohio**

License to practice as a respiratory care professional reinstated, and subject to probationary terms, conditions and limitations for at least five years. Based on the respiratory care professional having completed all the requirements for reinstatement of license pursuant to the terms of the 02/08/2023 Consent Agreement. Agreement effective 8/9/23.
