Please find below a summary of actions taken or initiated by the State Medical Board of Ohio and an update of Board matters pending or decided in courts as of August 13, 2025.

**PRE-HEARING SUSPENSIONS**

**CAMPBELL, Andrew R., M.D., (#57.250894) - Toledo, Ohio**

Pursuant to Section 4731.22(I), Ohio Revised Code, license to practice medicine and surgery is automatically suspended by operation of law based upon his plea of no contest and finding of guilt in the Lucas County Common Pleas Court to three felony counts of Aggravated Arson. Order effective 8/13/25. (See also: Citations/ Proposed Denials below.)

**COOLEY, David A., M.D., (#35.049465) - Harrod, Ohio**

Pursuant to Section 4731.22(G), Ohio Revised Code, license to practice medicine and surgery summarily suspended based on Board's determination that there is clear and convincing evidence that the licensee is in violation of Section 4731.22(B)(22), Ohio Revised Code, and that his continued practice presents a danger of immediate and serious harm to the public. Order effective 8/14/25. (See also: Citations/Proposed Denials below.)

finding of guilt of, or a judicial finding of eligibility for intervention in lieu of conviction for, a felony. Notice of Automatic Suspension and Opportunity for Hearing effective 8/13/25.

**COOLEY, David A., M.D., (#35.049465) - Harrod, Ohio**

Based on allegations that a prior disciplinary action by the Colorado Medical Board, which issued a 5/13/25 Stipulation and Final Agency Order that was based on the doctor's treatment of three patients which failed to meet generally accepted standards of medical practice, constitute: any of the following actions taken by an agency responsible for authorizing, certifying, or regulating an individual to practice a health care occupation or provide health care services in this state or another jurisdiction, for any reason other than the nonpayment of fees: the limitation, revocation, or suspension of an individual's license to practice; acceptance of an individual's license surrender; denial of a license; refusal to renew or reinstate a license; imposition of probation; or issuance of an order of censure or other reprimand. Notice of Summary Suspension and Opportunity for Hearing effective 8/14/25.

**FU, Giulian, M.T. Applicant (APP-000412723) - Dayton, Ohio**

Based on the submission of an application to practice massage therapy, and on allegations when the massage therapist failed to respond to Board staff regarding discrepancies in her application, and failed to respond to the Board's Investigative Subpoena for Deposition and Interrogatories, those acts and or omission individually and/or collectively constitute: failure to cooperate in an investigation conducted by the Board, including failure to comply with a subpoena or order issued by the Board or failure to answer truthfully a question presented by the Board in an investigative interview, an investigative office conference, at a deposition, or in written interrogatories. Notice of Opportunity for Hearing effective 8/22/25.

**MUDE, Priyanka J., D.P.M., (#36.110003) - North Canton, Ohio**

Based on allegations when the doctor plea of guilty and conviction in the Stark County Common Pleas Court, to one felony count of Aggravated Possession of Drugs, one felony count of Illegal Processing of Drug Documents, and one felony count of Forgery, constitute: a plea of guilty to, a judicial finding of guilt of, or a judicial finding of eligibility for intervention in lieu of conviction for, a felony. Notice of Opportunity for Hearing effective 8/14/25.

**SCHOENY, Yan Ren, M.T. Applicant (APP-000510390) - Milford, Ohio**

Based on the submission of an application to practice massage therapy, and on allegations when the massage therapist failed to respond to the Board's investigative subpoena, and failed to submit answers in response to Board Interrogatories, those acts and or omission individually and/or collectively constitute: failure to cooperate in an investigation conducted by the board, including failure to comply with a subpoena or order issued by the board or failure to answer truthfully a question presented by the board in an investigative interview, an investigative office conference, at a deposition, or in written interrogatories, except that failure to cooperate with an investigation shall not constitute grounds for discipline under this section if a court of competent jurisdiction has issued an order that either quashes a subpoena or permits the individual to withhold the testimony or evidence in issue. Notice of Opportunity for Hearing effective upon service.

**SERRANO, Eric R., M.D., (#35.064279) - Pickerington, Ohio**

Based on allegations the doctor engaged in sexual misconduct with respect to two specified patients; those acts and or omissions individually and/or collectively constitute: violating or attempting to violate,

directly or indirectly, or assisting in or abetting the violation of, or conspiring to violate, any provisions of this chapter or any rule promulgated by the Board, to wit: Prohibitions regarding sexual misconduct, which also constitute a departure from, or the failure to conform to, minimal standards of care of similar practitioners under the same or similar circumstances, whether or not actual injury to a patient is established. Notice of Opportunity for Hearing effective 8/19/25.

**SPIDELL, Tanika S., D.O., (#34.016749) - Dayton, Ohio**

Based on allegations when the doctor prescribed dangerous drugs and controlled substances to four identified patients, whom were family members, in a non-emergency situation without properly documenting office visits or progress notes, and failed to complete and maintain medical records accurately reflecting the utilization of controlled substances in connection with treatment and diagnosis, those acts and or omissions individually and/or collectively constitute: violating or attempting to violate, directly or indirectly, or assisting in or abetting the violation of, or conspiring to violate, any provisions of this chapter or any rule promulgated by the Board, to wit: Utilizing controlled substances for self and family members, and General Provisions, which also constitute a failure to maintain minimal standards applicable to the selection or administration of drugs, or failure to employ acceptable scientific methods in the selection of drugs or other modalities for treatment of disease; and selling, giving away, personally furnishing, prescribing, or administering drugs for other than legal and legitimate therapeutic purposes or a plea of guilty to, a judicial finding of guilt of, or a judicial finding of eligibility for intervention in lieu of conviction of, a violation of any federal or state law regulating the possession, distribution, or use of any drug; and a departure from, or the failure to conform to, minimal standards of care of similar practitioners under the same or similar circumstances, whether or not actual injury to a patient is established. **WIRTH, Christina H., M.T., (#33.014248) - Marysville, Ohio**

Based on a prior disciplinary action by the Ohio Board of Nursing which issued a 11/18/21 Order, and on allegations when the massage therapist failed to reply to the Board Interrogatories and Board emails, those acts and or omissions individually and/or collectively constitute: any of the following actions taken by an agency responsible for authorizing, certifying, or regulating an individual to practice a health care occupation or provide health care services in this state or another jurisdiction, for any reason other than the nonpayment of fees: the limitation, revocation, or suspension of an individual's license to practice; acceptance of an individual's license surrender; denial of a license; refusal to renew or reinstate a license; imposition of probation; or issuance of an order of censure or other reprimand; and failure to cooperate in an investigation conducted by the Board, including failure to comply with a subpoena or order issued by the Board or failure to answer truthfully a question presented by the Board in an investigative interview, an investigative office conference, at a deposition, or in written interrogatories. Proposed denial of application to practice massage therapy, based on the submission of an application for a license to practice massage therapy, and on allegations that the massage therapist's course of instruction does not meet Ohio's requirements for in-person clock hours, and has not held an active massage therapy license, registration or certificate in good standing in another state during the five-year period immediately preceding the date of application. **MUNEERUDDIN, Samina, M.D., (#35C.001465) - Huntingdon Valley, Pennsylvania (Non-Disciplinary)**

Proposed termination of expedited license issued through the Interstate Medical Licensure Compact Commission, based on allegations the doctor has not redesignated her state of principal license to an eligible compact state. Notice of Opportunity for Hearing 8/21/25.

**REIKHER, Daniel, M.D., (#35C.000941CTR) - West Palm Beach, Florida (Non-Disciplinary)**

Proposed termination of expedited license issued through the Interstate Medical Licensure Compact Commission, based on allegations the doctor has not redesignated her state of principal license to an eligible compact state. Notice of Opportunity for Hearing 8/20/25.

**RUBY, Jason, R.C.P., (#RCP.9141) -Lucasville, Ohio (Non-Disciplinary)**

Based on the submission of an application for restoration of license to practice medicine and surgery, and on allegations that the doctor has not been engaged in the active practice of medicine and surgery for more than two years. **ANDERSON, Stuart Douglas, M.D., (#35.081721) - Pittsburgh, Pennsylvania**

License to practice medicine and surgery suspended for an indefinite period of time, but not less than six months, and subject to conditions for reinstatement including completion of medical records and professional ethics courses and payment of a three thousand five hundred dollar (\$3,500.00) fine, and probationary terms, conditions and limitations for a period of at least one year with a monitoring physician in the same or similar specialty. Based on the finding that a prior disciplinary action by the West Virginia Board of Medicine which issued a 5/9/24 Consent Order, constitute: any of the following actions taken by an agency responsible for authorizing, certifying, or regulating an individual to practice a health care occupation or provide health care services in this state or another jurisdiction, for any reason other than the nonpayment of fees: the limitation, revocation, or suspension of an individual's license to practice; acceptance of an individual's license surrender; denial of a license; refusal to renew or reinstate a license; imposition of probation; or issuance of an order of censure or other reprimand. Order effective 8/27/25.

**BASHA, Samer, M.D. Applicant (APP-000907679) - Allentown, Pennsylvania (Non-Disciplinary)**

Denial of application to practice medicine and surgery. Based on the doctor's submission of an application to practice medicine and surgery, and on the finding that the doctor has not completed an examination sequence acceptable to the Board, and does not currently hold an ABMS or AOA specialty board certification. Order effective 8/14/25. (Journal Entry-No Hearing Requested).

**BODJANAC, Stephen M., D.O., (#34.006963) - Sarasota, Florida**

License to practice medicine and surgery suspended for an indefinite period of time, but not less than two years, and subject to conditions for reinstatement including completion of a physician patient boundaries course and payment of a fifteen thousand dollar (\$15,000.00) fine, followed by probationary terms, conditions and limitations for at least two years. Based on the finding when the doctor entered into a sexual relationship with a patient despite the existence of a doctor-patient relationship, those acts and/or omissions individually and/or collectively constitute: violating or attempting to violate, directly or indirectly, or assisting in or abetting the violation of, or conspiring to violate, any provisions or any rule promulgated by the Board, to wit: Prohibition from engaging in sexual misconduct, which also constitute a departure from, or the failure to conform to, minimal standards of care of similar practitioners under the same or similar circumstances, whether or not actual injury to a patient is established. Board order effective 8/29/25.

**CENTA, Joseph E., M.D., (#35.081040) - Milan, Ohio (Non-Disciplinary)**

Denial of application for expedited licensure. Based on the doctor's submission of an application for Expedited License, and Letter of Qualification to participate in the Interstate Medical Licensure Compact Commission, and on the finding that the doctor does not meet the basic requirements for an LOQ according to the IMLC due to prior disciplinary action. Order effective 8/15/25. (Journal Entry-No Hearing Requested).

**EBINGER, Peggy G., M.D., (#35.058043) - Norfolk, Virginia (Non-Disciplinary)**

Application for restoration of license to practice medicine and surgery granted conditioned upon passage of the Special Purpose Examination (SPEX) and the Post-Licensure Assessment System (PLAS) within six months of the date of the order. Based on the doctor's submission of an application for restoration of her license to practice medicine and surgery, and on the fact she has not been engaged in the active practice of medicine and surgery for more than two years. Order effective 8/14/25.

**FEINZIMER, Benjamin A., D.O., (#34C.000023)**

License to practice osteopathic medicine and surgery indefinitely suspended, but not less than six months, and subject to conditions for reinstatement including completion of required pharmacology and professional ethics courses and payment of a three thousand five hundred dollar (\$3,500.00) fine, followed by probationary terms, conditions and limitations for at least one year. Based on the finding that a prior disciplinary action issued by the Mississippi State Board of Medical Licensure which issued a Determination and Order of stayed suspension of the doctor's license, constitute: any of the following actions taken by an agency responsible for authorizing, certifying, or regulating an individual to practice a health care occupation or provide health care services in this state or another jurisdiction, for any reason other than the nonpayment of fees: the limitation, revocation, or suspension of an individual's license to practice; acceptance of an individual's license surrender; denial of a license; refusal to renew or reinstate a license; imposition of probation; or issuance of an order of censure or other reprimand. Order effective 8/27/25.

**LUCCHESE, Christopher F., D.O., (#34.005843) - Sherman, Texas**

License to practice osteopathic medicine and surgery permanently revoked, and subject to payment of a twenty thousand dollar (\$20,000.00) fine. Based on the finding that the doctor's plea of guilty in the United States District Court for the Northern District of California with conspiring to defraud the United States, that act and or omission individually and/or collectively constitute: selling, giving away, personally furnishing, prescribing, or administering drugs for other than legal and legitimate therapeutic purposes or a plea of guilty to, a judicial finding of guilt of, or a judicial finding of eligibility for intervention in lieu of conviction of, a violation of any federal or state law regulating the possession, distribution, or use of any drug; and a plea of guilty to, a judicial finding of guilt of, or a judicial finding of eligibility for intervention in lieu of conviction for, a felony. Order effective 8/14/25. (Journal Entry-No Hearing Requested).

**MITCHELL, Zachary M., M.T., (#33.024968) - Westerville, Ohio**

License to practice massage therapy permanently revoked and subject to payment of a ten thousand dollar (\$10,000.00) fine. Based on the finding when the massage therapist engaged in sexual impropriety with one patient when he neglected to employ proper draping practices which fully exposed the patient's buttocks while performing a skin-on-skin gluteal massage, and engaged in sexual contact with that patient when he put his hand inside her intergluteal cleft and rubbed her anus and vagina, those acts and or omissions individually and or collectively constitute: violating or attempting to violate, directly or indirectly, or assisting in or abetting the violation of, or conspiring to violate, any provisions of this chapter or any rule promulgated by the Board, to wit: Prohibitions regarding sexual misconduct, which also constitute a departure from, or the failure to conform to, minimal standards of care of similar practitioners under the same or similar circumstances, whether or not actual injury to a patient is established. Order effective 8/26/25.

**RICHARDSON, Henry, M.D., (#35.152832) - San Diego, California (Non-Disciplinary)**

Rescission of previously approved application for Expedited License and Letter of Qualification to participate in interstate Medical Licensure Compact Commission, based on the finding that the doctor does not meet the basic requirements for an LOQ because he does not hold a specialty certification or a time-unlimited specialty certificate recognized by the American Board of Medical Specialties or the American Osteopathic Association's Bureau of Osteopathic Specialists. Order effective 8/28/25. (Journal Entry-No Hearing Requested).

**HADLEY, Vanessa, M.D. Applicant (APP-000909577) - Dayton, Ohio (Non-Disciplinary)**

Application for a license to practice medicine and surgery granted. Based on the doctor's submission of an application to practice medicine and surgery, and on her subsequent submission of additional information concerning her participation in the American Board of Anesthesiology Maintenance of Certification process, testing, and course work. Agreement effective 8/13/25.

**KHAN, Sami Muhammad, D.O., (#34.013290) - Zanesville, Ohio**

License to practice medicine and surgery reprimanded and subject to completion of required medical records and professionalism and ethics courses, and payment of a three thousand five hundred dollar (\$3,500.00) fine. Based on the doctor's admission when he complimented a patient's appearance twice, once during a breast examination and again during a pelvic examination, which was perceived by the patient to be sexual in nature and not clinically relevant to the patient, and then subsequently terminated by his employer following an internal investigation, those acts and/or omissions individually and/or collectively constitute: a departure from, or the failure to conform to, minimal standards of care of similar practitioners under the same or similar circumstances, whether or not actual injury to a patient is established. Agreement effective 8/13/25.

**MANNING, Paul Michael, D.O., (#34.007688)**

License to practice osteopathic medicine and surgery suspended for a definite period of 90 days, and subject to payment of a four thousand five hundred dollar (\$4,500.00) fine. Based on the doctor's admission when he entered a plea of guilty in the Cleveland Heights Municipal Court to one misdemeanor count of Disorderly Conduct, as a lesser included offense from initial criminal charges of Domestic Violence and Assault, those acts and/or omissions individually and/or collectively constitute: a plea of guilty to, a judicial finding of guilt of, or a judicial finding of eligibility for intervention in lieu of conviction for, a misdemeanor involving moral turpitude. Agreement effective 8/13/25.

**NG, Margaret Leung, M.D., (#35.064502) - Flatwoods, Kentucky**

License to practice medicine and surgery reprimanded, and subject to permanent limitation from treating and or prescribing medications to pediatric patients under age 18 for mental health/psychiatric health conditions, including but not limited to, prescribing medications and controlled substances to treat ADD/ADHD, Bipolar disorder and anxiety disorders. License also subject to general probationary requirements, and payment of a three thousand five hundred dollar (\$3,500.00) fine. Based on the doctor's admission when, with respect to the care and treatment of six identified patients, she inappropriately treated and/or failed to appropriately treat and/or failed to appropriately document treatment of those patients, such as excessive medication dosing, poor consistency in medications prescribed and doses, document monitoring symptoms of psychiatric disorders, document what was being treated for each medication, assess the efficacy and adverse effects, document how a diagnose was made and how symptoms were monitored, assess and document patient safety, those acts and/or omissions individually and/or collectively constitute: failure to maintain minimal standards applicable to the selection or administration of drugs, or failure to employ acceptable scientific methods in the selection of drugs or other modalities for treatment of disease, which also constitute a departure from, or the failure to conform to, minimal standards of care of similar practitioners under the same or similar circumstances, whether or not actual injury to a patient is established. Agreement effective 8/13/25. Terms, conditions, and limitations of Agreement not effective until 9/13/25.

**SNYDER, Kathryn L., M.T., (#33.026700) - Chillicothe, Ohio**

License to practice massage therapy indefinitely suspended, and subject to general probationary requirements, and conditions for reinstatement. Based on the massage therapist's admission when she violated the terms and conditions of a Confidential Monitoring Program Agreement with Ohio Professionals Health Program by engaging in the use of marijuana and then subsequently declining OhioPHP's request to sign a non-practice agreement and ending her participation in the Confidential Monitoring Program Agreement, those acts and/or omissions individually and/or collectively constitute: impairment of ability to practice according to acceptable and prevailing standards of care because of substance use disorder or excessive use or abuse of drugs, alcohol, or other substances that may impair ability to practice. Agreement effective 8/13/25.
