Please find below a summary of actions taken or initiated by the State Medical Board of Ohio and an update of Board matters pending or decided in courts as of January 8, 2025.

PRE-HEARING SUSPENSIONS

LOIUDICE, Jean Anne Lang, D.O., (#34.002323) – Mogadore, Ohio

Pursuant to Section 4731.22(G), Ohio Revised Code, license to practice osteopathic medicine and surgery summarily suspended based on Board's determination that there is clear and convincing evidence that the licensee is in violation of Section 4731.22(B)(19), Ohio Revised Code, and that her continued practice presents a danger of immediate and serious harm to the public. Order effective 01/08/2025. (See also: Citations/Proposed Denials below.)

LOIUDICE, Jean Anne Lang, D.O., (#34.002323) – Mogadore, Ohio

Based on allegations when the doctor violated the terms of her non-practice agreement with Ohio PHP when she called in a prescription for a patient, and also contacted another practitioner about prescribing a patient medication for vertigo, those acts and or omissions, individually and or collectively constitute: Inability to practice according to acceptable and prevailing standards of care by reason of mental illness or physical illness, including, but not limited to, physical deterioration that adversely affects cognitive, motor, or perceptive skills. Notice of Summary Suspension and Opportunity for Hearing Effective 01/08/2025.

LUCCHESE, Christopher D.O., (#34.005843) – Sherman, Texas

Based on allegations that the doctor's plea of guilty in the United States District Court for the Northern District of California with conspiring to defraud the United States, that act and or omission individually and/or collectively constitute: selling, giving away, personally furnishing, prescribing, or administering drugs for other than legal and legitimate therapeutic purposes or a plea of guilty to, a judicial finding of guilt of, or a judicial finding of eligibility for intervention in lieu of conviction of, a violation of any federal or state law regulating the possession, distribution, or use of any drug; and a plea of guilty to, a judicial finding of guilt of, or a judicial finding of eligibility for intervention in lieu of conviction for, a felony. Notice of Opportunity for Hearing Effective 01/09/2025.

RAJA, Mansoor A., M.D., (#35.123474) – Pittsburgh, Pennsylvania

Based on allegations that a prior disciplinary action by the West Virginia Board of Medicine which issued a 07/29/2024 Consent Order, individually and/or collectively constitute: Any of the following actions taken by an agency responsible for authorizing, certifying, or regulating an individual to practice a health care occupation or provide health care services in this state or another jurisdiction, for any reason other than the nonpayment of fees: the limitation, revocation, or suspension of an individual's license to practice; acceptance of an individual's license surrender; denial of a license; refusal to renew or reinstate a license; imposition of probation; or issuance of an order of censure or other reprimand. SEEDS, William A., M.D., (#35.070566) – Ashtabula, Ohio

Based on allegations, the doctor failed to comply with the provisions of two Standard Care Arrangement agreements which required the APRN to be a registered nurse and duly licensed as an acute care nurse practitioner, and that the collaborating physician specialize in the practice of psychiatry and pain management. Despite those provisions, the APRN was not registered in acute care, and the doctor's specialty is as an orthopedic surgeon with a practice area of cellular medicine, those acts and or omissions individually and/or collectively constitute: failure of a physician or podiatrist to enter into a standard care arrangement with a clinical nurse specialist, certified nurse-midwife, or certified nurse practitioner with whom the physician or podiatrist is in collaboration pursuant to section 4731.27 of the Revised Code or failure to fulfill the responsibilities of collaboration after entering into a standard care arrangement; and violating or attempting to violate, directly or indirectly, or assisting in or abetting the violation of, or conspiring to violate, any provisions of this chapter or any rule promulgated by the Board, to wit: Standard Care Arrangements. Notice of Opportunity for Hearing Effective 01/09/2025.

SOZEN, Ibrahim M.D., (#35.135611) – Medina, Ohio

Based on allegations with respect to the care and treatment of one specified patient, when the doctor inserted a Uterine Sound into her vagina without the patient's consent, that act and or omission individually and/or collectively constitute: violating or attempting to violate, directly or indirectly, or assisting in or abetting the violation of, or conspiring to violate, any provisions of this chapter or any rule promulgated by the Board, to wit: Prohibitions regarding sexual misconduct, which also constitute a departure from, or the failure to conform to, minimal

standards of care of similar practitioners under the same or similar circumstances, whether or not actual injury to a patient is established. Notice of Opportunity for Hearing Effective 01/09/2025.

SUNDARAM, Shankar, M.D., (#35.140498) – Oakwood, Ohio

Based on allegations that prior disciplinary proceedings by: the Medical Board of California, which issued an 04/11/2024 Decision, and the Texas Medical Board which issued an 08/16/2024 Waiver Order, individually and/or collectively constitute: any of the following actions taken by an agency responsible for authorizing, certifying, or regulating an individual to practice a health care occupation or provide health care services in this state or another jurisdiction, for any reason other than the nonpayment of fees: the limitation, revocation, or suspension of an individual's license to practice; acceptance of an individual's license surrender; denial of a license; refusal to renew or reinstate a license; imposition of probation; or issuance of an order of censure or other reprimand. License to practice osteopathic medicine and surgery permanently revoked, and subject to payment of a three thousand five hundred dollar (\$3,500.00) fine. Based on the finding when the Drug Enforcement Agency issued a decision and order revoking the doctor's DEA Certificate of Registration, that act constituted: the revocation, suspension, restriction, reduction, or termination of clinical privileges by the United States department of defense or department of veterans affairs or the termination or suspension of a certificate of registration to prescribe drugs by the drug enforcement administration of the United States department of justice. MEEHAN, Michael P., M.T., (#33.024262) – Westlake, Ohio

License to practice massage therapy permanently revoked and subject to payment of an eight thousand dollar (\$8,000.00) fine. Based on the finding that the massage therapist's plea of guilty and conviction to one felony count of Practicing Medicine without a License, and one felony count of Arson, in the Cuyahoga County Court of Common Pleas, those actions and/or omissions, individually and/or collectively constitute: a plea of guilty to, a judicial finding of guilt of, or a judicial finding of eligibility for intervention in lieu of conviction for, a felony. POPA, Carmen, M.D., (#35.079249) – Parma Heights, Ohio

License to practice medicine and surgery permanently revoked and subject to the payment of a twenty thousand dollar (\$20,000.00) fine. Based on the finding when the doctor stole glasses of another doctor, inappropriately prescribed scheduled II stimulates to patients for the purpose of weight loss, failed to document testing to diagnose the condition, failed to access or document accessing OARRS at the times or intervals required by the Board's rules, and failed to appear for a scheduled deposition, and produce records in response to a Board issued subpoena, those acts and or omissions, individually and or collectively constitute: the commission of an act that constitutes a felony in this state, regardless of the jurisdiction in which the act was committed, to wit: Theft; and also constitute violating or attempting to violate, directly or indirectly, or assisting in or abetting the violation of, or conspiring to violate, any provisions or any rule promulgated by the Board, to wit: Utilization of anabolic steroids, schedule II controlled substance cocaine hydrochloride, schedule II controlled substance stimulants, and prescribing for subacute and chronic pain, which also constitute failure to maintain minimal standards applicable to the selection or administration of drugs; and selling, giving away, personally furnishing, prescribing, or administering drugs for other than legal and legitimate therapeutic purposes, and with respect to patients 3, 4, 8 and 10, the Standards and procedures for review of "Ohio Automated Rx Reporting System;" and also constitute a departure from, or the failure to conform to, minimal standards of care of similar practitioners under the same or similar circumstances, whether or not actual injury to a patient is established; and also constitute making a false, fraudulent, deceptive, or misleading statement in the solicitation of or advertising for patients, in relation to the practice of medicine and surgery, osteopathic medicine and surgery, podiatric medicine and surgery, or a limited branch of medicine, or in securing or attempting to secure any license or certificate to practice issued by the Board; and also constitute a failure to cooperate in an investigation conducted by the board, including failure to comply with a subpoena or order issued by the board or failure to answer truthfully a question presented by the board in an investigative interview, an investigative office conference, at a deposition, or in written interrogatories.
