Agency Mission & Goals

The State Medical Board of Ohio issues licenses and oversees the practice of allopathic physicians (MD), osteopathic physicians (DO), podiatric physicians (DPM), massage therapists (LMT), and cosmetic therapists (CT) under the authority of the Medical Practices Act, Chapter 4731, Ohio Revised Code (ORC). The Medical Board continues to regulate naprapaths and mechanotherapists licensed by the board before March 1992.

The Medical Board also regulates Physician Assistants, ORC Chapter 4730; Dietitians, ORC Chapter 4759; Anesthesiologist Assistants, ORC Chapter 4760; Respiratory Care Professionals, ORC Chapter 4761; Acupuncture & Oriental Medicine, ORC Chapter 4762; Radiologist Assistants, ORC Chapter 4774; and Genetic Counselors, ORC Chapter 4778.

The Medical Board's regulatory responsibilities include investigating complaints against applicants and licensees and taking disciplinary action against those who violate the public health and safety standards set by the General Assembly and the Medical Board.

Agency Mission

To protect and enhance the health and safety of the public through effective medical regulation.

Agency Goals

- > Ensure persons practicing medicine meet sufficient standards of education, training, competence and ethics.
- Define and advocate for standards of safe medical practice.
- Prohibit persons from practicing medicine whose violations are so egregious as to forfeit the privilege or who otherwise lack the legal authority.
- Provide information about the licensees of the Medical Board, the board's functions and operations, and the laws governing the practice of medicine.
- Achieve and maintain the highest possible levels of organizational efficacy.

Composition

The State Medical Board of Ohio is composed of twelve members: nine physicians (seven MD, one DO, one DPM) and three non-physician public members. The board members are appointed by the governor and serve five-year terms. Appointment terms are staggered to provide continuity and board members may be reappointed. Two members are selected by their peers on the board to serve as the board's Secretary and Supervising Member who oversee the investigatory and enforcement processes.

During FY19, the Medical Board met each month in the Administrative Hearing Room on the 3rd floor of the Rhodes Office Tower, 30 East Broad Street, Columbus, Ohio. Meeting agendas and minutes are available on the board's website, med.ohio.gov. The board met on January 25, 2019 by telephone conference to issue a summary suspension to a licensee. A special meeting was held on May 23, 2019 to discuss its statutory authority under Section 4731.22(F)(5) of Ohio Revised Code. The annual board retreat was held on June 10, 2019 to discuss operational issues and processes.

Appointments to Board: On August 1, 2018 Gov. John R. Kasich reappointed Robert Giacalone to a public member position on the board for a term ending July 31, 2023. Governor Mike DeWine appointed Jonathan Feibel, MD and Harish Kakarala, MD on May 21, 2019 to serve as allopathic physician representatives on the board with terms ending March 18, 2024. They replaced Andrew Schachat, MD and Ronan Factora MD, who completed five years of service on the Medical Board.

Agency Staffing and Funding: The Executive Director oversees day-to-day operations of the agency. During FY19, staffing levels included 84.5 positions. Medical Board operations are funded exclusively through licensing and other authorized fees that are non-general revenue fund sources.

Staffing Strategy: Whenever a vacancy occurs, the board re-examines the need for the specific duties and priorities before backfilling the position. In many cases a vacant position may be repurposed to another area of higher need. During FY19 the board continued to operate within its personnel ceiling of 84.5 positions. Temporary services were used as needed to address any gaps in workflow.

About the Medical Board

Board Committees: The Medical Board addresses a variety of issues through its standing committees. Committees formulate recommendations that are forwarded to the full board for action. Committee meetings are generally held the day of the monthly board meeting and committee agendas are posted on the Medical Board's website. Board actions on committee recommendations are included in the board meeting minutes.

The Physician Assistant (PA) Scope of Practice Committee met for the final time during FY19. Ohio Senate Bill 259 made several changes which eliminated the need for such a committee. The legislation eliminated the PA formulary which outlined prescriptive restrictions. As a result, the business of the PA Scope of Practice Committee was limited enough that all remaining duties and responsibilities were incorporated into Licensure Committee. SB259 also impacted the Physician Assistant Policy Committee (PAPC): reducing the previous requirement of two pharmacist members down to one pharmacist; eliminating the requirement for four meetings annually and allowing the committee to meet as needed; and allowing committee members full participation rights via teleconference. Although committee members may call in, PAPC meetings remain open to the public and anyone may attend a meeting in-person.

Fiscal Report

FY19 Revenue by Revenue Category

Medical Board operations are funded exclusively through licensing and other authorized fees. The agency receives no funding from the state's general revenue sources. The board received \$10,113,151 in revenue in FY19.

The board finished the year spending well under its \$11,064,757 budget. Final numbers will not be available until November 2019, when the board finalizes spending from its FY19 encumbrances (purchase orders).

The Medical Board's spending authority is authorized by the legislature through the biennial budget process. FY20 began July 1, 2019 with a budget allotment of \$10,862,471.

In January 2018 the Medical Board acquired the former Respiratory Care and Dietetics Boards' responsibilities and licensees. This resulted in increased revenue of over \$1 million during FY18. The bulk of these licensees will renew again during FY20.

Ohio Physician Loan Repayment Program (OPLRP)

Ohio physician loan repayment program contribution for FY19: \$446,420

Physician licensure biennial renewal fees are \$305, and \$285 of the fee supports Medical Board operations. The remaining \$20 is transferred to the Department of Health for the Ohio Physician Loan Repayment Fund as required in ORC 4731.281(A). This program is designed to increase access to primary care for underserved communities and populations. In exchange for loan repayment assistance, physicians commit to practice for a minimum of two years at an eligible site in a Health Professional Shortage Area (HPSA) or Health Resource Shortage Area, accept Medicare and Medicaid, and see patients regardless of ability to pay.

NOTE: Because of the state's biweekly pay schedule, each fiscal year has an extra day (2 in leap year) beyond the 26 pay periods of 14 days each. The accumulation of these days year after year results in one extra pay period (the 27^{th} pay period) in a fiscal year approximately every 10 years. The fiscal year 2020-2021 transportation budget (Am. Sub. H.B. 62, Sect. 509.30) authorized the Director of Budget and Management flexibility to process the 27^{th} pay period in fiscal year 2019. Therefore, funds for the 27^{th} pay period were encumbered against fiscal year 2019 but were disbursed in fiscal year 2020. The cost of the 27^{th} pay period was \$300,541.71, which is not included in the figures above.

The State Medical Board of Ohio continues to be financially solvent, with a cash balance of \$4,947,746 as of June 30, 2019.

Licensure Activities

The licensure responsibilities of the Medical Board ensure that those practicing medicine and the other professions regulated by the agency meet sufficient standards of education, training, competency and ethics. The training, education and other requirements for licensure for each profession established through Ohio law are available on the Medical Board's website. The count includes Ohio license holders living both in-state and out-of-state.

Staff continue to engage in continuous improvement efforts that redefine work processes, aligning with the eLicense system capabilities, identifying and resolving system issues as they arise, and identifying system enhancements to improve the user experience. All applications and renewals are processed and paid via credit card online through the eLicense system except naprapath, mechanotherapist, and restricted cosmetic therapist applications.

Volunteer's Certificates: ORC 4731.295 allows the board to issue a volunteer's certificate to an MD or DO who has retired from active practice so that the doctor may provide medical services to indigent or uninsured persons. A volunteer's certificate holder may not accept any form of remuneration for providing medical services. The certificate is valid for three years and may be renewed. One volunteer certificate was issued in FY19.

Training Certificate Process Change: Until 9/27/2017, training certificates issued to those participating in Ohio medical residency or fellowship training programs had to be renewed annually. Provisions in HB49 changed the length of time a training certificate is valid from one year to three years. The significantly reduced number of training certificates renewed in FY19 illustrates the impact of this change. In addition, the board streamlined the process for training certificate applications, resulting in the issuance of 2.200 training certificates within the 75 workdays between the National Residency Match Day on March 15, 2019 and the commencement of training programs on July 1, 2019. Prior to this change, the same number of applications would have taken six to nine months to fully process.

Physician Assistant Supervision Agreements: Prior to the enactment of HB111 on 9/28/2018, physicians were required to submit to the board copies of their supervision agreements with physician assistants, and to submit changes to the agreements as they occurred. The change in law eliminated the filing requirements; instead, agreements are now simply required to be maintained at physicians' offices, which board staff may audit for compliance.

Continuing Education Audits: The board has been working with CE Broker to simplify the continuing education audit process for licensees and board staff, resulting in an increase in the number of audits performed, and a decrease in the time required to complete audits.

Certificates to Recommend Medical Marijuana: The number of physicians who hold a Certificate to Recommend (CTR) has continued to increase. The board issued 374 CTRs in FY19 and had 512 active CTR holders as of June 2019. Only Ohio licensed MDs and DOs may apply for a CTR.

Licensure Examinations: Licensure examinations for allopathic physicians (MD), osteopathic physicians (DO), and podiatric physicians (DPM) are administered by national examining boards and are offered throughout the year in a computerized format. Successful completion of national certification examinations is also required for those applying for licensure as an anesthesiologist assistant, radiologist assistant, physician assistant, dietitian, genetic counselor, massage therapist, acupuncturist, oriental medicine practitioner or respiratory care professional.

The Medical Board administers a licensure examination for cosmetic therapy applicants. Fifteen candidates sat for the cosmetic therapy licensure exam which was offered four times during FY19. Successful completion of the Ohio exam is required for cosmetic therapy licensure.

Limited Branch Schools: The Medical Board issues Certificates of Good Standing to schools offering courses in massage therapy or cosmetic therapy that satisfy the statutory requirements for curriculum content and instruction hours. The complete list of approved limited branch schools is available on the board's website, med.ohio.gov.

Licensure Renewal

The Medical Board uses a staggered system for the biennial licensure renewal of allopathic physicians, osteopathic physicians, podiatric physicians, massage therapists and cosmetic therapists. The first letter of the licensee's last name determines if the license expires on January 1, April 1, July 1, or October 1, in either even numbered or odd numbered years.

The licenses of anesthesiologist assistants, physician assistants, radiologist assistants, genetic counselors, acupuncturists and oriental medicine practitioners expire on January 31 of even-numbered years. Licenses of dietitians and respiratory care professionals expire on June 30 of even numbered years.



Complaints


The Medical Board protects the public through effective medical regulation. The board investigates complaints, takes disciplinary actions against those who violate the Medical Practices Act and other applicable statutes and rules, and monitors licensees on probation.

Complaints inform the board of potential problems with a licensee's practice. Complaints are received from a variety of sources, including the public, agency staff, state and national regulatory agencies, physicians, self-reports from licensees, hospitals, and others such as law enforcement and the media.

Types of complaints received include patient care concerns, inappropriate prescribing issues, discrepancies in licensure application information, criminal activity, impairment due to chemical dependency, ethical violations, office practice management concerns, and other issues.

Two Medical Board members, the Secretary and the Supervising Member, oversee the agency's investigative and enforcement activities. Complaints are reviewed to determine if the board has jurisdiction over the subject of the complaint, and if so, if the allegations violate a section of Ohio law or a rule enforced by the Medical Board. The complaints received, and investigations conducted by the board are confidential per ORC 4731.22(F).

Investigations

Investigations

The Investigations Unit of the Medical Board is composed of field investigators and supervisors who are based throughout the state. By harnessing the features of eLicense, Investigations was able to reduce the number of open complaints within the Investigations Unit by over 12% during FY19.

To further increase efficiency throughout the agency, Investigations staff communicated with 263 hospitals throughout Ohio and made arrangements related to service of board subpoenas and the production of hospital records. Additionally, the Medical Board continues to routinely work with a variety of local, state, and federal agencies. Board investigative staff participated in the

Appalachian Regional Prescription Opioid Strike Force which, in April 2019, took action involving 60 charged defendants across 11 federal districts encompassing over 32 million doses of controlled substances.

Finally, to further strengthen effective outreach to members of the public affected by sexual assault perpetrated by licensees of the board, the Investigations Unit attended a two-day training provided by the Ohio Attorney General's Interpersonal Violence Response Training Team.

Standards Review

Standards Review

The Standards Review section is part of the Medical Board's confidential investigatory process; it is designed to address quality of care complaints. The Medical Board contracts with physicians, and other industry professionals to evaluate certain complaint allegations to determine if the minimal standard(s) of care has been provided to the patient. While some complaints are sent on for formal disciplinary action, most complaints evaluated by this section are resolved via non-disciplinary means.

This section focuses on intervention, with the goal to guide licensees who are beginning to show poor practice patterns or who are failing to keep up with changes in practice standards. With successful intervention, the licensee benefits by improving practice methods; patients benefit from having a better practitioner available to address their healthcare needs; and the Medical Board protects the public without an adverse impact on the availability of care in the community.

Currently, two nurses are employed by the board to manage the complaints in the Standards Review section. In FY19, the Standards Review section reviewed 622 complaints. It closed 459 complaints following review without taking any further action. Additionally, 123 licensees were referred to remedial education and/or were cautioned regarding their practice. As part of the review process, 873 subpoenas were issued.

Enforcement

Enforcement

Enforcement staff review the complaints referred to the section by the board's Secretary and Supervising Member and prepare the cases for possible disciplinary action. Enforcement attorneys prepare citations, as well as Summary Suspensions, Immediate Suspensions and Automatic Suspensions. They also negotiate Consent Agreements and Voluntary Surrender/Retirements.



Glossary of Board Action Terms

- Revocation: The loss of a license to practice in Ohio. An individual whose license has been revoked shall be eligible to apply for a new license.
- Suspension: The temporary loss of a license to practice in Ohio. A suspension shall be imposed for either a
 definite or an indefinite period.
- Probation: A situation whereby the license holder shall continue to practice only under conditions specified by the board.
- Reprimand: The license holder is formally and publicly reprimanded in writing.
- Voluntary Surrender/ Retirement: Practitioner surrenders/retires license to practice in lieu of further disciplinary proceedings; may authorize the board to revoke the practitioner's license without further legal proceedings.
- Denial: The denial of an application for a license to practice in Ohio. The board may permanently deny an application which prohibits the applicant from ever applying for a license in the future.
- Withdrawal of application: Applicant no longer wants to pursue an Ohio license.
- Summary Suspension: License to practice is suspended prior to a hearing based on clear and convincing
 evidence that continued practice by the licensee poses a danger of immediate and serious harm to the
 public.
- Immediate Suspension: License to practice is suspended prior to a hearing pursuant to Section 3719.121, Ohio Revised Code, when a licensee pleads guilty to, is found by a judge or jury to be guilty, or is found eligible for intervention in lieu of conviction, of a felony drug abuse offense.
- No Further Action: The board finds that a violation occurred but declines to impose any disciplinary sanction.
- Permanent Revocation: The permanent loss of a license to practice in Ohio and the inability to ever reapply for or hold any license to practice in Ohio.

Compliance

The Medical Board's compliance staff monitored 239 licensees on probation in FY19. Probationers are usually required to attend periodic office conferences with the Board Secretary or designee to verify that the licensee is fulfilling the specific requirements of the Board Order or Consent Agreement. Compliance staff members participate in nearly 20 such conferences each month.

During FY19, the Medical Board approved 125 requests from licensees on probation for remedial education course approvals, chart review, or other modifications related to compliance with their board sanction. The board also approved the release of 45 licensees from the probationary terms and conditions included in their Board Order or Consent Agreement.

Compliance staff are also responsible for verifying that treatment providers, approved by the board to provide services to licensees with chemical dependency issues, maintain compliance with the requirements in ORC 4731.25 and in OAC 4731-16. The list of approved treatment providers is available on the Medical Board's website, med.ohio.gov.

The Medical Board's compliance staff also monitored two licensees as part of its B(19) Confidential Monitoring Program. This program, which began in December of 2018, enables eligible licensees to participate in a non-disciplinary confidential monitoring program related to a mental or physical illness (other than a substance use disorder).

Administrative Hearings

The Medical Board's Attorney Hearing Examiners conduct the administrative hearings of practitioners who request a hearing regarding a Notice of Opportunity for Hearing issued by the Medical Board. Following the conclusion of the administrative hearing, the Hearing Examiner prepares a Report & Recommendation (R&R) that includes the basis for the hearing, the findings of fact, conclusions of law and a proposed sanction for consideration by the board members. During FY19, 47 administrative hearings were held.

In some situations, the practitioner does not request an administrative hearing. If that occurs, the board can either act based upon the information in the Notice of Opportunity for Hearing, which often occurs in less complex cases, or it can request a Hearing Examiner review the board's evidence to support the charges and prepare a Proposed Findings and Proposed Order, which includes a proposed sanction for consideration by the board members. It is similar in format to a Report & Recommendation, but there is no hearing and there is no evidence presented by the respondent, who waived his or her right to a hearing by failing to submit a hearing request. During FY19, the Hearing Examiners prepared 13 Proposed Findings and Proposed Orders.

The Attorney Hearing Examiners also preside at public rules hearings regarding administrative rules promulgated by the agency. They prepare a report of the hearing for consideration by the board members. Ten public rules hearings were held in FY19.

The Medical Board receives numerous requests for copies of public records each year. While many documents are available through the Medical Board's website, requests for more complex records are provided by the agency.

Requests for disciplinary action files, licensure files and board meeting materials are the most frequently requested documents. A response to a public records request may require providing hundreds, and in a few cases, thousands of pages of material.

Education and Outreach Activities

The State Medical Board of Ohio worked diligently throughout FY19 to educate licensees and Ohioans about safe and effective health care.

Preventing Opioid Misuse: Continuing the fight against the nation's opioid epidemic, the State Medical Board of Ohio launched several educational campaigns. The board created and disseminated an educational video and hand out to help prescribers comply with regulations on prescriptions for chronic and subacute pain. Additionally, SMBO purchased and distributed approximately 400 drug disposal pouches which can safely dissolve unused opioids and help decrease the chance for diversion.



Cultural Competency: Through collaborative efforts with numerous local, state and federal organizations, the State Medical Board of Ohio published "Cultural & Linguistic Competency for Improved Health Outcomes in Ohio," a guide for providers as an introduction to cultural competencies. This document draws on resources from across the country, including review and input from a diverse group of experts. The guide is meant to be a starting point for developing linguistic and cultural competencies among health care providers. The printed booklet is also available electronically through the website. It will be used to produce an educational video which is expected to be available before the end of 2019.

Medical Board eNews: In FY19, the Medical Board prepared and distributed 12 issues of the Medical Board eNews to licensees. This electronic newsletter keeps licensees

abreast of policy and rules updates that impact their practice. Issues of eNews are available on the Medical Board's website.

CTR eNews: An additional monthly electronic newsletter was created with the intent of educating physicians with an active Certificate to Recommend (CTR) Medical Marijuana about the Ohio Medical Marijuana Control Program.
