

## Ohio Medicaid 1915(c) Waiver Comparison Charts

The following charts contain various types of information about Ohio’s Medicaid 1915(c) home- and community-based (HCBS) waiver programs, including the services offered, how to apply, and the enrollment figures. The listed waiver programs include Ohio Department of Medicaid (ODM) managed waivers (MyCare Ohio, Ohio Home Care Waiver, OhioRISE Waiver), Ohio Department of Aging (ODA) managed waivers (Assisted Living, PASSPORT), and Ohio Department of Developmental Disabilities (DODD) managed waivers (Individual Options, Level One, SELF). Charts are updated monthly with enrollment figures for the current month.

### Definitions of Key Terms

**Unduplicated capacity:** Number of individuals who can receive HCBS services during the specified waiver year.

**Unduplicated enrollment:** Number of individuals receiving or who have received HCBS waiver services during the specified waiver year.

**Enrollment for the month:** Number of individuals receiving HCBS services during the specified month.

**Waiver Year:** For all waivers, except MyCare, the waiver program year is based on the state fiscal year (SFY), which runs from July-June. Unlike other waiver programs, the MyCare Ohio waiver program year is based on the calendar year (January-December).
