Ohio's Home- and Community-Based Waiver Programs for Older Adults and People with Disabilities

Home- and community-based services (HCBS) allow Ohioans covered by Medicaid to get healthcare services and support in their own home or community instead of a nursing home, hospital, or other long-term care facility. Ohio Department of Medicaid (ODM) offers four HCBS waiver programs serving older adults and people with disabilities. Each program gives enrollees control over their care while remaining in their communities.

The following pages offer a glimpse into each HCBS waiver program, what it takes to be eligible and the state agency that oversees the program.

HCBS Waiver Programs for Older Adults and People with Disabilities

Ohio has four waiver programs for older adults and people who have disabilities who meet a nursing facility level of care. The "Waiver Comparison Chart" on pages 4 and 5 shows what each program offers and who is eligible. The Ohio Administrative Code links below provide state regulations and details on each program.

The four programs are listed below with links to the Ohio Administrative Rule about the program:

1. **Assisted Living**- serves people aged 21 and older who live in an Ohio Department of Aging certified licensed residential care facility.

2. **MyCare Ohio**-serves people aged 18 and older who meet a hospital or nursing level of care. Managed care plans provide services. MyCare Ohio is in certain counties only.

3. Ohio Home Care-serves people aged 0-59 with physical disabilities in the home.

4. **PASSPORT**-serves people aged 65 and older, and people with physical disabilities aged 60-64. Services are provided in the home instead of a nursing home.

Base Eligibility

To get services from Ohio's HCBS waiver programs for older adults and people with physical disabilities, certain conditions must be met. All programs require people to:



Department of Medicaid

- Be eligible for Medicaid. This means a person will:
 - Be a United States citizen or meet Medicaid citizenship requirements.
 - Have or get a Social Security number.
 - Be an Ohio resident.
 - Meet financial requirements.
- Meet a nursing facility (NF) based level of care (i.e., intermediate or skilled) as outlined in <u>Rule</u> <u>5160-3-08 - Ohio Administrative Code | Ohio Laws</u>.
- Need and use at least one waiver service monthly. See the Waiver Comparison Chart on pages 4 and 5 for a list of services.
- Services offered in the program can meet health-related needs in ways that are safe for the enrollee while in a community setting instead of a nursing facility.
- Agree to participate in the person-centered planning process.

Complete eligibility regulations are described in Chapter <u>5160:1</u> | <u>Ohio Department of</u> <u>Medicaid</u> | <u>Eligibility</u>. People will be assessed for eligibility during the enrollment process.</u>

Request to Enroll

The first step to access HCBS waiver programs is to make a request. Ohio Department of Medicaid's Form 02399 is used to request a waiver and is submitted to either the County Department of Job and Family Services or the regional PASSPORT Administrative Agency. Waiver Comparison

Assisted Living

Assisted living is provided in a community-based residential facility. People pay for their room and board. Services help with daily needs, nursing, meals, and social activity.

MyCare Ohio

MyCare is a special project offered in 29 Ohio counties. It combines Medicare and Medicaid benefits. People get services through a MyCare Ohio managed care plan.

Ohio Home Care Waiver

The Ohio Home Care Waiver gives services to people at home and in the community instead of a nursing home, hospital, or other facility.

PASSPORT

The PASSPORT program helps Ohioans ages 60 years and older to get services and supports they need to stay in their homes or other community settings, rather than enter nursing homes. Monthly service costs are limited to \$14,700 per month.

Eligibility Comparison

Assisted Living

- Have a nursing facility level of care.
- Aged 21-64 and have a physical disability.



- Aged 65 or older.
- Can make room and board payments.
- Lives in a residential care facility (RCF) licensed by the Ohio Department of Health.

MyCare Ohio

- Have a nursing facility level of care.
- Age 18-64 and have a physical disability.
- Aged 65 or older.
- Eligible for Medicare parts A, B and D.

Live in one of these Ohio counties: Fulton, Lucas, Ottawa, Wood, Lorain, Cuyahoga, Lake, Geauga, Medina, Summit, Portage, Stark, Wayne, Trumbull, Mahoning, Columbiana, Union, Delaware, Franklin, Pickaway, Madison, Clark, Green, Montgomery, Butler, Warren, Clinton, Hamilton, and Clermont

Ohio Home Care Waiver

- Have a nursing facility level of care.
- Aged 0-59 and have a physical disability.

PASSPORT

- Have a nursing facility level of care.
- Aged 60-64 and have a physical disability.
- Aged 65 or older.
- Service costs do not go over \$14,700 per month.

Operated by the Ohio Department of Medicaid.
