

Step 1. Click on the **More** button at the top of the screen.




Step 2. Hover your mouse over the **Language and speech** button in the dropdown.



Step 3. Select the **Turn on live captions** button.



State Agency Updates

- The Ohio Department of Developmental Disabilities (DODD), Ohio Department of Medicaid (ODM), and Sandata representatives met with the Provider Support Workgroup made up of county board staff who provide support to DODD providers at the local level to get feedback and to hear suggestions on ways to better support providers in the developmental disabilities space.
- DODD, ODM, and Sandata representatives presented at the Ohio Association of County Boards of Developmental Disabilities (OACBDD) spring conference on the October 1 roll-out for DD providers.
- DODD is reviewing the current [Waiver Services Code Reference Guide](#) to add a column to indicate services which require the use of EVV.
- DODD and the Ohio Department of Aging (ODA) are collaborating with Sandata and ODM on the development of training to prepare their local agencies for the claim validation implementation.
- ODM, DODD, and ODA are developing call center transfer processes to ensure providers get to the right people to address their questions during claims validation implementation.

Electronic Visit Verification Alternate Vendors

Alternate Electronic Visit Verification Vendors: Challenges

In the April 28 workgroup, the items below were identified as issues, barriers, or challenges with using an alternate EVV vendor.

- ✓ Lack of responsiveness.
- ✓ Limited interaction between the alternate EVV system and Sandata system.
- ✓ Using different alternate EVV systems based on the payer.

Potential payers include ODM, ODA, DODD, or Managed Care Entities (MCEs).

There are **63** alternate EVV vendors that are currently approved by ODM.

There are **780** alternate EVV accounts with visit data in the Sandata Aggregator system.

762

762 of those alternate EVV accounts are currently billing for EVV services.
