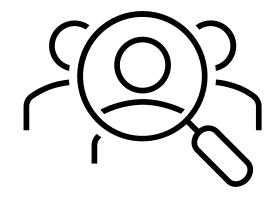

Ohio Administrative Code

Ohio Administrative Code

Rule 5160-32-03 Alternate electronic visit verification (EW) Vendor.

Provider responsibilities:

- Notify Ohio Medicaid of intent to use an alternate vendor.
- Complete alternate system aggregator training.
- Ensure visit data is in aggregator and reflects the visit as it occurred.
- Ensure billing is supported by visit data.
- Obtain and maintain alternate vendor certifications.



Recipient Records

New Recipient Records

- All new recipient records are validated against the Ohio Department of Medicaid (ODM) recipient eligibility system.
- The PatientBirthDate and EffectiveStartDate are required for Sandata to correctly validate the recipient data against ODM's recipient eligibility system.
 - Ensures Sandata has valid recipient data for claims validation.
 - Eliminates the need for providers to create new records for newborns and Ohio Department of Aging (ODA) State-Funded recipients requiring EW before receiving a Medicaid ID.





Recipient Record Updates

- Sandata is aware of unexpected behavior related to updating existing recipient records in alternate vendor systems.
- Vendors have found when sending the same PatientOtherID with a new Medicaid ID, the recipient is not updating.
- The vendor can send a new recipient record with the correct Medicaid ID and resend visits with the new **PatientOtherID** and correct Medicaid ID.
- Work is being done to investigate and resolve this issue.

Recipient Address Requirement

- The Recipient address is required.
- A Post Office (P.O.) box is an acceptable form of address in the Recipient record.
 - This is important to note for those individuals who are enrolled on <u>Ohio's Safe at Home program</u>.

Multiple Recipient Addresses

- If the address within the Recipient Web Service is different from the address provided by the alternate vendor, Sandata appends the address provided by the alternate vendor and the address from ODM's recipient eligibility system.
 - The address provided by the alternate vendor is the primary.
 - The address from the recipient web service is the secondary.

Direct Care Worke Employee Records

- Agency providers who use an alternate vendor have the option to also use the Sandata Electronic Visit Verification (EVV) system for only their subcontracted therapists.
- Providers using both systems need to ensure employee records are captured in the appropriate accounts.



Alternate Electronic Visit Verification ptions When Using Subcontracted Therapists

Option 1

Medicaid Provider uses **two** EVV accounts to capture and maintain visits

- Account A: Alternate EVV Account
- Account B: Sandata EVV Account is used for subcontracted therapy services

For Account B above, subcontracted therapists can use Sandata's single log in functionality in the Sandata Mobile Connect application

Alternate Electronic Visit Verification and Subcontracted Therapists. Option 1 of 2.

Provider steps for option 1:

- 1. Agency submits a request to OHAltEVV@sandata.com with the request to obtain a Sandata system account B to use in addition to their Alternate EVV account A.
 - This request must include the Provider Medicaid ID number.
- 2. Provider adds subcontracted therapists into the Sandata system using their email addresses. Bulk upload is an option.
- 3. Subcontracted therapists can use one email address to log into the Sandata Mobile Connect and they will then have the option to choose the agency from a dropdown.





Alternate Electronic Visit Verification and Subcontracted Therapists. Option 2 of 2.

Provider steps for option 2:

- 1. All services subject to EVV are captured in the alternate vendor system, including services captured by subcontracted therapists.
- 2. Subcontracted therapists must use the alternate vendor system's login functionality, which may result in multiple login credentials for each contracted provider.



Bulk Upload in Sandata Electronic Visit Verification

- Home health agencies can export a <u>bulk upload</u> template that can be completed by the subcontracted entity for the purpose of adding multiple DCW or employees into Sandata's system at the same time. This can be helpful to agencies who subcontract therapists.
- Please review the <u>bulk upload sample</u> document on the EVV website for further clarification. Once the form is uploaded agency administrators will need to navigate to each direct care worker record and select the mobile user box.





Visit Data



Location and Visit Data

- Logging GPS coordinates is optional and may only be done with written consent of the person receiving services.
- The GPS capture requirement applies to alternate vendor source systems.
- Recommend using <u>ODM 10375 EVV GPS Consent form</u> to provide consent for GPS logging You may also use your own consent form if it collects all the data elements contained in the ODM form.
- Providers must demonstrate that consent has been obtained and maintained. Consent is effective from the date of recipient's signature on the form for a period of one year or 365 calendar days.

Location and Recipient Records

- Recipient latitude and longitude are not required; however, any recipient address with a corresponding GPS location will have the GPS appended to the recipient record.
- Global Positioning System (GPS) coordinates cannot be appended to a P.O. box.

Modifiers

- If an alternate vendor is sending a procedure code with a modifier, they will need to utilize the **Modifier1** field.
- Amodifier can be included in the **IndividualPayerInformation** segment of the Recipient record.
- Amodifier can be included in the Visit record.
- The modifier value of U9 can be provided with procedure codes T1001 or G0493.

Reason Codes

- The alternate vendor data collection system will be expected to send a reason code "99" and attestation that proper documentation exists for any manual entry or data edit.
- Avalue of "99" is the only reason code accepted.
 - Sandata has deployed a system fix to allow historical change segments to include old reason codes.
