

# Community Transition Resources in Ohio

## RESIDENTIAL STATE SUPPLEMENT

Provides financial assistance to adults with a disability who can live in eligible living arrangements (i.e., Class Two Residential Facilities or Adult Care Facilities).

### Eligibility Criteria:

- Eligible for or enrolled in Medicaid; and
- Receiving Social Security, Supplemental Security Income (SSI) or Supplemental Security Disability Insurance (SSDI).

Eligible individuals may have a monthly income up to \$1,300 and up to \$2,000 in assets\*.

### Funds May Cover:

- Accommodations
- Supervision
- Personal Care Services

## RECOVERY REQUIRES A COMMUNITY

Provides financial assistance to adults with a behavioral health diagnosis to transition from nursing homes to sustainable community living.

### Eligibility Criteria:

- Enrolled in Medicaid;
- Presents with behavioral health diagnosis (includes mental illness or substance use disorders); and
- Currently receiving treatment in a nursing home and plans to transition to the community, **OR** recently transitioned from a nursing facility (within the last 90 days) to the community.

### Funds May Cover:

- Short-term housing assistance;
- One-time payment of utility arrears;
- Supplemental independent living assistance (such as homemaker/personal care services or peer recovery support services); and
- Other needs to support independent living in the community.

- Documentation of a behavioral health diagnosis, e.g., face sheet

## HOME Choice

Provides assistance for adults to move from a long-term care facility into a home and community-based setting of their choice.

### Eligibility Criteria:

- Enrolled in Medicaid;
- Have resided in a long-term care facility for at least 60 consecutive days;
- Have income to sustain community living;
- Participate in an assessment that establishes a need for the program; and
- Have care needs that can be adequately met in a community setting.

### Services and Supports:

- **Transition Coordination** – collaborate with a Transition Coordinator to create a plan to return to the community, which may include locating housing, establishing a dwelling, linking to community services and supports, develop and execute a discharge plan.
- **Community Transition Services** – funds to pay for expenses to establish community-based living. May include: Security deposits and rental expenses required to obtain a lease, essential household items, fees and deposits for utilities and other services (e.g. phone, electricity, gas, water), moving expenses, pre-transition transportation.
