

# **Ohio Coordinated Specialty Care for First Episode Psychosis Treatment Programs**

With the right treatment and support, people affected by a first episode of psychosis *can* and *do* get better. The opportunities for living a quality life are much greater if they receive Coordinated Specialty Care for First Episode Psychosis (CSC for FEP) *as soon as possible after symptoms begin*. CSC for FEP is appropriate for individuals between the ages of 15-35 with recent onset of psychotic symptoms.

CSC for FEP treatment is available at community mental health agencies in the Ohio counties highlighted below.
