Nurse Licensure Compact (NLC)

- Beginning January 1, 2023, Ohio will join the NLC.
- All new RN/LPN applicants who meet eligibility requirements may apply for a multi-state license (MSL) in Ohio.
- Ohio nurses with MSLs will be authorized to practice in other participating NLC states.

Tips for Licensure Success

- Complete your application for licensure by examination in <u>eLicense</u> no more than 60 days before graduation.
- Share your application number, in the correct format, with your program advisor.
- Begin your criminal background check (including FBI) through Ohio BCI approximately 60 days before graduation.
 - Select OBN as the <u>Direct Copy</u> <u>Receiver</u> on all background check forms. No paper submissions please.
- Your letter of completion will be sent by <u>your program</u> when you graduate.
- The <u>Ohio Board of Nursing</u> will make you exam eligible once all required materials are received.
- Make sure to use your legal name on your application <u>and</u> when registering with Pearson VUE. Your name must match exactly to receive your Authorization to Test (ATT).
- Your ATT will come directly from Pearson VUE.
- Sign up for the NCLEX as soon as possible after receiving your ATT.
