

#### ADDENDUM No. 01 DNR-230018 REBID

## Hocking Hills Wastewater Improvements 2023-24 Hocking Hills State Park April 2, 2024

#### All Bidders:

This Addendum is issued to modify the original Project Manual and Drawings and is hereby made a part of the Contract Documents. This Addendum shall be attached to the Project Manual(s) in your possession and shall become a part of your bid. Bidders shall review changes to all portions of the work, as changes to one portion may affect the work of another portion and include all such related changes. Please notify all subcontractors of this addendum.

- 1. The Prebid Meeting agenda and the sign-in sheet from the pre-bid meeting are attached for reference.
- 2. Attached is additional information pertaining to the EDGE Requirements as reviewed at the pre-bid meeting.
- 3. Question: Section 46 61 41. Part 2.2.A.2 Please note that the minimum thickness of the tank is 10 ga instead of 3/16 in.

Answer: Minimum 10 ga is acceptable.

- 4. Question: Sheet C6. Filter building layout
  - a. Please confirm the need of a check valve on the backwash discharge.
  - b. Please confirm the correct size of the backwash line to equalization tank.
  - c. The platform at the filter stops short on the back side. Please confirm there is access to the drive unit.

#### Answers:

- a. Delete the 2-inch check valve on the backwash discharge line.
- b. The backwash discharge line and gate valve shall be 3" diameter.
- c. Extend the platform around the filter to the back left corner of the filter for ease of access to the drive unit.
- 5. Question: In the Geotech report, the borings from 8/16/21 are not directly at the new Filter Building area. Were other borings performed in the area of the new Filter Building?

Answer: No additional borings are available at this time.



6. Question: Spec Section 33 32 16 Submersible Grinder Pump Station 2.2. R. Aluminum hatches. Is Halliday Products considered an equal?

Answer: Yes.

7. Question: Spec Section 33 41 00 Storm Utility Drainage Piping, 2.4, B. Manhole Frames and Covers: Conform to Cambridge standards as shown on Cambridge Construction Drawing S-12.

Answer: Disregard the reference to the City of Cambridge.

8. Question: Existing Campground LS, Plan Sheet C5A indicates 2" PVC piping. Piping materials in Spec 33 20 20 indicates ductile iron; at this time, 2 inch ductile iron pipe is not readily available.

Answer: Schedule 80 PVC piping and valves are acceptable in the campground lift station rehab work.

9. Question: Park Office LS, Spec 33 32 16, 2.2, Items S., T., and U. appear to be for fiberglass pump stations.

Answer: Disregard items related to fiberglass pumpstations. The Park office lift station shall be precast concrete wet well and valve pit.

10. Question: Plan Sheet C5, Notes 3 and 16 indicate 8" piping to/from Post-Aeration manhole. Plan Sheet C3 depicts 6" piping to/from Post-Aeration manhole.

Answer: The piping to the post aeration manhole and to the filter building shall be 8-inch diameter.

11. Question: Spec 40 97 20 Flow Metering and Recording, indicates that the ultrasonic flow meter to be programmed for weir and flume calculations. Plan Sheet 6 and A4 do not depict any weir or flume.

Answer: This is typically provided as part of the overall plant submittals by the WWTP manufacturer. It is an open top stainless steel box, approximately 4'-6" by 2'-6" with a 22-1/2" V-Notch Weir, allowing the open channel meter (sensor) to be placed above.

12. Question: Plan Sheet A4, Coded Note 3, please confirm that there is no hoist beam for this project

**Answer: Correct** 



13. Question: Please confirm the voltage/phase for the disk filter.

Answer: 208 Volt Three Phase.

14. Question: Section 46 61 41. Part The Design data in Part shows 50,000 gpd max day flow, however, in same section Parts 1.3.E.2 and E.3 specify 25,000 gpd. Please clarify.

Answer: The disk filter shall be designed to treat up to 50,000 gpd, but the anticipated flow rate is approximately 25,000 gpd.

15. Question: Specification 06 83 16 Fiberglass Reinforced Wall Paneling, 2.01, A., mentions Nufiber FRP panels laminated to fire rated gypsum board but item d. indicates it is to be laminated on plywood. Drawing A5, detail 9, calls out Nufiber FRP on ½" gypsum board. We have been advised that the Nufiber FRP laminated to fire rated gypsum board is only available on 5/8" fire rated gypsum board.

Answer: The Fiberglass reinforced wall paneling will be NuFiber with FRP laminated to 5/8" fire rated gypsum board.

16. HDPE Pipe for Force Main: Please confirm the type of pipe to be used for the directionally drilled force main.

Answer: Force main pipe material shall be HDPE pipe, PE-3408, meeting ASTM D-3350. The pipe shall be manufactured in accordance with ASTM F-714, for Polyethylene Plastic pipe DR-11. All joints shall be butt fused together in a fashion approved by the pipe manufacturer. HDPE Pipe shall meet ductile iron pipe outside diameter. Pipe shall be installed with tracer wire to facilitate locating after installation.

A signed copy of this Addendum must be included with the bid submission. This Addendum does NOT change the bid date and time. Addendum 01 does NOT change the estimated construction cost for this project.

The undersigned states that the changes and/or clarifications described in this Addendum have been incorporated in his/her bid submission.

#### **Encouraging Diversity Growth and Equity (EDGE) Requirements**
