Project Overview

A. Project Description

Appalachian Behavioral Healthcare is a secure hospital that contains patient and administrative space. Total square footage is roughly 70,000, with 1/3 of the space consisting of office space, conference rooms and other common areas. This project will reconfigure the administrative space to meet current operational needs.

B. Scope of Services

Full design services including Schematic, Design Development, Construction Documents, Construction Administration and Closeout services.

- Proposer's previous experience (numbers of projects, sizes of projects) when working with its proposed consultants.
- Specification writing credentials and experience.
- Experience and capabilities of creating or using Critical Path Method (CPM) schedules and of using CPM schedules as a project management resource.
- Approach to and success of using partnering and Alternative Dispute Resolution.
- Proximity of prospective firms to the project site.
- Proposer's apparent resources and capacity to meet the needs of this project.
- The selected A/E and all its consultants must have the capability to use the Internet within their normal business location(s) during normal business hours.

If the A/E firm intends to receive points for exceeding the EDGE Participation Goal, it must provide BOTH a completed *Commitment to Participate* form AND a completed *Statement of Intent to Contract and to Perform* forms signed by both parties with its *Statement of Qualifications*.

Failure to do so may cause their *Statement of Qualifications* to be rejected.
